#### **General Undertakings and Conditions**

All riders, teams, officials and other parties participating in the FIM Motocross World Championships undertake, on behalf of themselves, their employees and agents, to observe all the provisions of the:

- 1. FIM Sporting Code
- 2. FIM Motocross Regulations
- 3. FIM Motocross Technical Regulations
- 4. FIM Disciplinary and Arbitration Code
- 5. FIM Motocross Circuit Standards
- 6. FIM Environmental Code
- 7. FIM Medical Code
- 8. FIM Anti-Doping Code
- 9. FIM Annuaire
- 10. FIM Organiser's Manual

of the current year, as supplemented and amended from time to time (hereinafter collectively referred to as the "FIM Motocross World Championship Regulations").

The FIM Motocross World Championship Regulations may be translated into other languages, but in case of any dispute regarding interpretation the English text will prevail.

It is the responsibility of each rider and/or team to ensure that all persons involved with their entries observe the FIM Motocross World Championship Regulations at all times. The responsibility of the rider, or any other person having charge of an entered motorcycle at any time during a meeting is joint and severally with that of the team.

All persons concerned in any way with an entered motorcycle or present in any capacity whatsoever in the Paddock, Waiting Zone, Repair and Signalling Zone or on the circuit, must carry an appropriate pass at all times during the meeting.

Actions judged by the officials responsible to be contrary to the FIM Motocross World Championship Regulations – or judged to be unsportsmanlike or against the best interests of the sport or the meeting in question – are subject to disciplinary actions as provided by the Arbitration and Disciplinary Code.

1. FIM World Championships

#### 01.1 FIM MOTOCROSS WORLD CHAMPIONSHIPS

#### 01.1.1 FIM World Championships

Each year, the FIM holds FIM Motocross World Championships.

These Championships are organised according to the FIM Motocross World Championship Regulations, Sporting Code, Chapter 30 – "FIM World Championships and Prize Events".

#### In addition to 01.1.1:

# 01.1.1.032 FIM MX1/MX2 Motocross World Championships 01.1.1.033 FIM MX3 Motocross World Championship

Individual FIM Motocross World Championships for riders and manufacturers:

- a) FIM MX1 Motocross World Championship;
- b) FIM MX2 Motocross World Championship;
- c) FIM MX3 Motocross World Championship.

These FIM Motocross World Championships may also be called FIM Motocross World Championships.

A series of FIM Motocross meetings counting towards the FIM Motocross World Championships will be organised.

#### 01.1.1.034 FIM Motocross of Nations

FIM Motocross World Championship for national teams, selected by the FMNs:

a) FIM Motocross of Nations.

#### 2. FIM World Championship Meetings

#### 01.1.2 FIM World Championship Meetings

FIM Motocross World Championships meetings must be inscribed in the Calendar.

These meetings must be staged on circuits that have been approved by the FIM and comply with the FIM Motocross World Championship Regulations (See FIM Standards for FIM Motocross Circuits).

No meeting may be organised before all the necessary legal authorisations have been obtained by the organiser.

Organisers are responsible for providing all facilities and personnel to ensure the safe, smooth and efficient running of the meeting.

The validity of the third party insurance must come into effect two days before the practices and terminate two days after the last race of the meeting.

FIM Motocross World Championship meetings begin at the scheduled time for technical and sporting verifications and end when all of the following have occurred:

- a) The final results have been approved;
- b) All deadlines for lodging protests have expired; and
- c) All technical, sporting and anti-doping controls have been concluded.

All officials, marshals and medical staff must remain available and fully operational at the circuit until the end of the protest period.

#### In addition to 01.1.2:

#### 01.1.2.032 FIM MX1/MX2 Motocross World Championships 01.1.2.034 FIM Motocross of Nations

The results are approved by the Race Direction.

If a protest is lodged, the results will not become official until a decision is taken by the Race Direction.

#### 2. FIM World Championship Meetings

All officials, marshals and medical staff must remain available to the Race Direction and the during the protest period.

#### 01.1.2.033 FIM MX3 Motocross World Championships

The results are approved by the International Jury.

If a protest is lodged, the results will not become official until a decision is taken by the International Jury.

All officials, marshals and medical staff must remain available to the FIM Race Director and the International Jury during the protest period.

#### 4. FIM Championship Criteria

# 01.1.4 FIM Championship Criteria 01.1.4.032 FIM MX1/MX2 Motocross World Championships 01.1.4.033 FIM MX3 Motocross World Championship

All organised meetings counting towards the corresponding FIM World Championship will be taken into consideration. However, the FIM Management Council or, if necessary, the FIM Executive Board is entitled, upon proposal from the FIM Motocross Commission and in exceptional circumstances, to make a decision deviating from this principle.

The winner of the FIM World Championship is the rider who has obtained the most points from all the Races of the Championship, irrespective of the number of Races he has completed.

In case of ties, the number of better placings will be taken into account.

If a tie still exists, the points scored in the last Race of the Championship will determine the order of placing in the final standings. If necessary, the points scored in the last but one Race of the Championship will determine the order of placing in the final standings, and so on...

For the FIM Manufacturers' World Championship, only the highest placed motorcycle of each Manufacturer will gain points, according to their position in each Race of the Championship.

In case of ties for the FIM Manufacturers' World Championship, the same conditions as for the riders will apply to determine the winner of the Championship.

In the case where a rider participates on motorcycles from different Manufacturers, it is the make of the motorcycle with which he has obtained the most points that will appear next to his name in the final standings, without, however, modifying the calculation for the FIM Manufacturers' World Championship.

The final FIM World Championship standings cannot be considered definitive until the time limits for protests and appeals have elapsed, all protests and appeals have been settled and a final decision has been taken by the competent bodies.

All FIM World Champions are obliged to attend the official FIM Prize-Giving Ceremony.

#### 5. Support Races

#### 01.1.5 Support Races

During a FIM Motocross World Championship meeting, support races may be permitted.

However, these support races, as well as any other activities such as the vehicular use of the circuit during the meeting, including demonstrations or exhibitions, must at all times receive prior authorisation from the FIM and the FIM Championship Promoter.

Authorisation from the FIM does not imply nor include any FIM involvement in and/or liability for these support races/activities which are not run under the aegis and the responsibility of the FIM.

Priority must at all times be given to the FIM Motocross World Championship programme.

#### In addition to 01.1.5:

#### 01.1.5.032 FIM MX1/MX2 Motocross World Championships 01.1.5.034 FIM Motocross of Nations

If necessary, the Race Direction can change the time schedule of these support races and/or other activities or cancel them.

#### 01.1.5.033 FIM MX3 Motocross World Championship

If necessary, the International Jury can change the time schedule of these support races and/or other activities or cancel them.

#### 1. Supplementary Regulations

#### 01.2 ENTRIES, RIDERS AND TEAMS

#### 01.2.1 Supplementary Regulations

The Supplementary Regulations (SR) must include all supplementary regulations to the Sporting Code and Appendices and include relevant provisions of the Environmental, Medical and Anti-Doping Codes, as well as details relative to the particular meeting. They must in no case modify the FIM regulations.

The Supplementary Regulations must be drawn up in conformity with the standard model established by the CMS (See copy published in this booklet).

The Supplementary Regulations must be published in the two official languages of the FIM and must be approved by the FMNR and the FIM.

Two copies must be sent to the Executive Secretariat no later than two months before the date of the meeting for approval by the FIM.

Two copies of the Supplementary Regulations must also be sent to the FIM Championship Promoter and all Federations having riders liable to participate in the meeting in question.

No amendment may be made to the Supplementary Regulations after its approval by the FIM or the FMNR and after the opening date for entries.

However, in exceptional circumstances, an amendment to the Supplementary Regulations may be authorised.

#### In addition to 01.2.1:

# 01.2.1.032 FIM MX1/MX2 Motocross World Championships 01.2.1.034 FIM Motocross of Nations

At the meeting, the Supplementary Regulations must subsequently be ratified by the Race Direction.

Amendments to the Supplementary Regulations must be approved by the FIM or the Race Direction and subsequently brought to the attention of all persons concerned

#### 1. Supplementary Regulations

#### 01.2.1.033 FIM MX3 Motocross World Championship

At the meeting, the Supplementary Regulations must subsequently be ratified by the International Jury.

Amendments to the Supplementary Regulations must be approved by the FIM or the International Jury and subsequently brought to the attention of all persons concerned.

#### 2. Acceptance of Entries

#### 01.2.2 Acceptance of Entries

Entries to a FIM Motocross World Championship meeting will be accepted for riders who:

- a) Are in possession of the appropriate FIM Motocross World Championship licence (see Art. 01.2.3 Age of Riders);
- b) Are authorised by their FMN;
- c) Have requested an entry before the closing date of the meeting.

Riders can take part in one, two or three Championship classes during a season, but are limited to one class at each meeting.

Riders may enter for one or more meetings counting for the FIM Motocross World Championships, always using the official/specific FIM entry form on which all the requested information regarding the rider, team, sponsor and make of motorcycle must be indicated.

# Entries must be requested and provisional entries and/or entry forms must be sent to the FIM Championship Promoter.

Provisional entries can be made by e-mail or telefax but must be confirmed with the duly completed official entry form.

It is recommended that a provisional entry indicates the following information:

- IMN number; FMNR; date and venue of the meeting in which the rider wishes to enter;
- Name and first name of the rider;
- FMN and World Championship licence number of the rider (if the licence has already been issued);
- Date of birth and nationality of the rider;
- Motorcycle and team of the rider.

Provisional entries must always be confirmed with the duly completed official entry form.

#### 2. Acceptance of Entries

Riders may be required to sign an individual entry form during the administrative control.

For each meeting, within 72 hours after the closing date for entries, the list of riders entered will be published.

The FIM Executive Secretariat will publish the list of riders entered.

#### In addition to 01.2.2:

#### 01.2.2.032 FIM MX1/MX2 Motocross World Championships

The number of entries to each meeting is limited to 40 riders in the MX1 class and **40** riders in the MX2 class. The procedure is the same for the entire World Championship. The following riders will be allowed to enter:

- a) In each class, a maximum of 38 riders entered by the FIM Championship Promoter:
- b) In each class, the FMNR may enter two riders. The FMNR must inform the FIM Championship Promoter, at the latest 15 days before the closing date of entries of the meeting, of the names of the two riders the FMNR wishes to nominate;
- c) If the FMNR does not inform the FIM Championship Promoter at the latest 15 days before the closing date of entries of the meeting, the latter may automatically dispose of these entries.
- d) As of 01.01.2010, a World Champion in the MX2 class will be allowed to defend his world title once only (in the year following the winning of the title).

The closing date for entries for the first meeting of the FIM Motocross World Championship is 60 days before the meeting.

As of the second meeting, the closing date for entries is 15 days before each meeting.

If at any point in time after the publication of the entry lists, the total number of entries should not reach 40 in each class, the FIM Championship Promoter is entitled to enter more riders in the respective class to reach the maximum authorised.

#### 2. Acceptance of Entries

The decision to admit these riders entered by the Promoter to the meeting must be made before the end of the technical verifications prior to the meeting in question.

For these riders entered by the FIM Championship Promoter, all listed entry conditions (apart from the closing date of entries) apply.

#### 01.2.2.033 FIM MX3 Motocross World Championship

For each meeting, there is no limitation on the number of entries per FMN. However, the participation of a minimum of 10 riders is guaranteed to the FMNR.

For each meeting, the closing date for entries is 30 days before the meeting in question.

In any case, the FIM Championship Promoter can enter up to 5 riders before the end of the technical verifications prior to the meeting.

The FIM Championship Promoter must then inform the rider's FMN, the FMNR and/or the organiser in writing, by fax or by e-mail before the end of the technical verifications prior to the meeting.

If at any point in time after the publication of the entry lists, the total number of entries should not reach 40, the FIM Championship Promoter is entitled to enter more riders to reach the maximum authorised number of 40 for the races. These riders must be entered before the end of the technical verifications prior to the meeting.

For **the** riders entered by the FIM Championship Promoter, all listed entry conditions (apart from the closing date of entries) apply.

#### 2. Acceptance of Entries

#### 01.2.2.034 FIM Motocross of Nations

Each FMN can enter one team only. Each team consists of three riders.

The motorcycles used by the riders are at the option of the team. However, each team must field:

- One rider on a MX1 class motorcycle,
- One rider on a MX2 class motorcycle.
- One rider on an "Open" class motorcycle which meets the requirements of the MX1, the MX2 or the MX3 class, at the option of the team.

Members of a team must be holders of the passport of the country which they represent but can be holders of a licence issued by any FMN.

Entry forms must be sent to the FIM Executive Secretariat.

The closing date for entries is 30 days before the meeting.

The FIM Executive Secretariat will publish the list of teams/riders entered.

Should an FMN consider that it has had its team entry wrongly refused; the matter may be submitted to the FIM Executive Secretariat who will take immediate action.

Any FMN/team who considers its entry has been unjustly refused and because of this finds itself aggrieved, can appeal or lodge a protest in accordance with the regulations of the appropriate discipline.

In any case, the FIM Championship Promoter can enter up to 5 teams before the end of the technical verifications prior to the meeting.

The FIM Championship Promoter must then inform the **FMN of the team and the FIM** in writing, by fax or by e-mail before the end of the technical verifications prior to the meeting.

For these teams entered by the FIM Championship Promoter, all listed entry conditions (apart from the closing date of entries) apply.

#### 3. Age of Riders

#### 01.2.3 Age of Riders

FIM Motocross World Championship licences for riders are issued, only when the rider has attained the minimum age, as indicated below:

FIM Motocross World Championship, MX1 class:
 FIM Motocross World Championship, MX2 class:
 FIM Motocross World Championship, MX3 class:
 16 years
 16 years

#### (As of 01.01.2010, the maximum age in the MX2 class will be 23 years).

The limit for the minimum age starts on the date of the rider's birthday and the limit for the maximum age finishes at the end of the **calendar** year in which the rider reaches the age of 50.

Applicants aged over 50 years must attach to their rider's licence request a certificate of medical fitness (including a normal exercise tolerance electrocardiogram).

#### 4. Replacement Riders

#### 01.2.4 Replacement Riders

#### 01.2.4.032 FIM MX1/MX2 Motocross World Championships

The replacement of an entered rider can be accepted.

Replacement riders will be eligible to replace riders among those entered who do not appear at the meeting.

The decision to admit one or more replacement riders to the meeting must be made before the end of the technical verifications prior to the meeting in question.

Once this deadline is passed, it will no longer be possible to enter a replacement rider

For the replacement riders, all listed entry conditions (apart from the closing date of entries) apply.

#### 01.2.4.033 FIM MX3 Motocross World Championship

Once the closing date of entries is passed, the replacement of riders can be accepted.

Thus, an FMN is authorised to replace one or more of the riders it has entered in a meeting at the closing date of entries. In no case can the original total number of entries in that meeting from the FMN be exceeded by the number of its replacement riders.

The FMN of the rider concerned must then inform the **FIM Championship Promoter** in writing, by fax or by e-mail before the end of the technical verifications prior to the meeting.

The FIM Championship Promoter is also authorised to replace one or more of the riders he has entered in a meeting after the closing date of entries. In no case can the original total number of entries in that meeting from the FIM Championship Promoter be exceeded by the number of his replacement riders.

For the replacement riders, all listed entry conditions (apart from the closing date of entries) apply.

Once this deadline is passed, it will no longer be possible to replace a rider.

#### 4. Replacement Riders

#### 01.2.4.034 FIM Motocross of Nations

Once an FMN has entered a team, the replacement of riders or the changing of classes by the team's riders can still be authorised.

In both cases, all listed entry conditions (apart from the closing date of entries) apply.

The FMN of the team concerned must then inform the FIM in writing, by fax or by e-mail before the end of the technical verifications prior to the meeting.

Once this deadline is passed, it will no longer be possible to replace a rider in the team.

#### 5. Reserve Riders

#### 01.2.5 Reserve Riders

#### 01.2.5.033 FIM MX3 Motocross World Championship

The reserve riders are non-qualified riders who will be eligible to take the place of any qualified riders who cannot participate in a Race.

In each class, the reserve riders are nominated after the qualifications and according to the criteria valid for the class concerned.

The reserve riders are not guaranteed an opportunity to participate in the races.

The decision to admit one or more reserve riders to a race will be made 10 minutes before the race in question when the waiting zone is closed. At that time, any reserve riders who are not allowed to start must leave the waiting zone.

A reserve rider who was not allowed to start in the first race can do so in the second race if required.

On the other hand, a reserve rider who took part in the first race will not be allowed to participate in the second race if all the qualified riders are in the waiting zone.

6. Starting Numbers

1/MX2 Motocross World Championships 3 Motocross World Championship

Every rider participating in a FIM Motocross World Championship will be allocated a permanent starting number for the season by the FIM Championship Promoter.

#### 01.2.6.034 FIM Motocross of Nations

**All the** teams in the FIM Motocross of Nations **final** standings **(meeting)** of the previous year will have their starting numbers reserved.

The starting numbers will correspond to the team's result in the **meeting** of the previous year and be allocated accordingly.

The winning team will be allocated numbers 1, 2, 3; the second placed team: 4, 5, 6, and so on.

The FIM issues starting numbers to all the other teams that enter the meeting.

#### 7. Non-Participation in a Meeting

#### 01.2.7 Non-Participation in a Meeting

Riders who enter a FIM Motocross World Championship meeting and who cannot take part are subject to the provisions of the FIM Motocross World Championship Regulations.

The FMN(s) of any riders who do not inform both the FIM and the organisers of their inability to attend, or who do not provide an acceptable reason, will be fined US\$ 190.– ( $\in$  150.–) by the FIM.

A rider who is present at a meeting and who does not take part in the practices and/or in the races and/or leaves the meeting must always inform the FIM Race Director of the reasons for his non-participation.

During a meeting, a rider must always attempt to succeed. If not, he shall not be allowed to continue the competition and is liable to be penalised.

#### In addition to 01.2.7:

# 01.2.7.032 FIM MX1/MX2 Motocross World Championships 01.2.7.034 FIM Motocross of Nations

Any rider, who is not attempting to succeed, is liable to be penalised by the Race Direction.

#### 01.2.7.033 FIM MX3 Motocross World Championship

Any rider, who is not attempting to succeed, is liable to be penalised by the International Jury.

8. Rider Apparel

#### 01.2.8 Rider Apparel

It is the responsibility of each rider to select a helmet and apparel which will provide appropriate protection.

The helmet, eye protection and equipment and protective clothing must be in accordance with the FIM Motocross World Championship Regulations.

Although the FIM approves materials, it does not endorse or guarantee specific products or manufacturers.

Riders must rely on their own judgement in the selection of helmets and apparel for protection and durability.

The following apparel must be worn by riders in all meetings:

#### 1. Helmets

Helmets must be marked with one of the official international standard marks mentioned in the FIM Motocross World Championship Regulations. Long hair must be contained within the helmet.

#### 2. Eve protection

Eye protection must be worn at the start of each practice, qualification or race.

#### 3. Equipment and protective clothing

This equipment includes but is not limited to: boots, gloves, jerseys, pants and a stone (or roost) shield/protector. It is permissible (although not recommended) for the stone (or roost) shield/protector to be worn without the shield for the back. Gloves must be worn at the start of each practice, qualification or race.

#### 8. Rider Apparel

#### 4. FIM Championship logo

Riders must display the FIM Championship logo (50 mm x 50 mm) on the upper front torso or shoulder area of their jersey or on their chest/back protector if the latter is worn over the jersey.

Riders can print the FIM Championship logo on their jerseys.

#### 5. Starting number

Riders must wear a dorsal starting number conforming to the FIM Motocross World Championship Regulations, Art. 01.76 of the FIM Motocross Technical Regulations.

Riders can print their starting number on their jerseys or display it on **the shield for the back** if the latter is worn over the jersey.

#### 6. Family name of the rider

The family name of the rider must appear on the shoulder line of the back of their jersey or **the shield for the back** if the latter is worn over the jersey.

#### In addition to 01.2.8:

#### 01.2.8.034 FIM Motocross of Nations

#### 1. Helmets

Helmets must be the same colour for each rider of the same team and must include, in the overall colour scheme, the colours of their national flag, represented in stripes, bands or other design.

#### 3. Equipment and protective clothing

The equipment and protective clothing must be the same colour for each rider of the same team and should include in the overall colour scheme, the colours of their national flag, represented in stripes, bands or other design.

8. Rider Apparel

#### 4. FIM Championship logo

Failure by the team to display the FIM Championship logo (FIM Motocross of Nations) on the upper front torso or shoulder area of the jersey or **stone** (or roost) shield/protector of its riders will result in a 50% reduction of the team's prizes.

#### 9. Rider/Mechanic/Team Clothing

#### 01.2.9 Rider/Mechanic/Team Clothing

All riders, mechanics and team members must present a clean and neat appearance.

Only appropriately dressed persons displaying the proper credentials will be allowed in restricted areas.

Cut-off jeans, sleeveless shirts and open-toe shoes are prohibited in the waiting zone, signalling and repair zone.

Riders, mechanics and team members are encouraged to display the FIM Championship logo on shirts/uniform/clothing.

#### In addition to 01.2.9:

#### 01.2.9.034 FIM Motocross of Nations

National teams are encouraged to have team shirts/uniforms/clothing for their riders, mechanics and team members.

These shirts/uniforms/clothing should include in the overall colour scheme, the colours of the team's national flag, represented in stripes, bands or other design.

#### 01.2.10 Rider Behaviour and Assistance

Riders must at all times adhere to the provisions of the FIM Motocross World Championship Regulations.

Riders must be physically and mentally fit to control their motorcycles in order to promote the safety of the other riders, team members, officials, spectators and other persons involved in the meeting.

Riders must report any underlying medical disorder or injury they may have to the CMO.

At any time during the meeting, on request of the technical steward, the riders must present themselves and/or their motorcycle(s) and/or equipment to the technical verification.

At all times during the meeting, a rider will be responsible for keeping his motorcycle in conformity with the rules.

Riders may be held responsible for the actions of their team members.

Riders and team members are forbidden to ride any motorised vehicle and/or bicycle on the track outside the official practice/qualifying sessions and races.

Riders must obey the official flag signals and the boards which convey instructions.

Riders must carry "on-board" cameras on their motorcycles when requested by the FIM Championship Promoter.

Riders are responsible for attending all riders' briefings and being aware of all information and instructions issued. Team members are encouraged to attend the riders' briefing.

During a meeting, a rider must always attempt to succeed. If not, he shall not be allowed to continue the competition and is liable to be penalised.

Riders must ride in a responsible manner which does not cause danger to other competitors or other participants in the meeting.

Riders must always start the Pre-Qualifying or Qualifying Practices from the waiting zone.

When the riders are on the course, consultation between them and team members is restricted to the approved signalling and repair zone. Riders who stop along the course to consult with others may hinder the progress of other riders, and such action will be considered as outside assistance.

Only the following signals are allowed between riders/motorcycles and persons connected with them: data and images from official timekeeping transponders and on-board cameras, pit board messages displayed in approved areas and "body language" communication by the rider. Radio communication with riders is strictly forbidden.

Any outside assistance on the course to the riders is forbidden unless it is provided by a marshal carrying out his duty in the interests of safety. Any infraction of this rule may be penalised.

Marshals may assist riders by lifting motorcycles, moving them to a safe place and holding them while repairs or adjustments are made. Any repairs or adjustments must be made by the rider, working alone with no outside assistance. Marshals **are not allowed to** assist riders to re-start their motorcycles.

Riders should use only the course. However, if they accidentally leave the course, they may continue by safely re-entering the course, without gaining an advantage, from the closest point to where they left the course.

Course cutting is forbidden. The penalty for attempting to gain an advantage by course cutting will be disqualification from the respective practice/race. Further penalties may be imposed.

A zone must be reserved for repairs and signalling during the practices and races. Only mechanics, signallers, representatives of the industry and essential officials bearing valid passes are permitted in this area.

Riders may enter the repair zone to receive assistance or to modify, adjust or replace any part of their safety apparel or motorcycle except the frame, which must be sealed. For silencers, refer to the FIM Motocross World Championship Regulations. Refuelling is permitted, but must be done with engines dead.

No replacement of safety apparel, refuelling or mechanical service may be carried out on the course or outside the repair zone or waiting zone.

Riders entering the repair zone must come to a complete stop. Violators will be disqualified from the practice/race in question.

Riders who stop their engines in the repair zone may be assisted in re-starting their motorcycles.

Riders who enter the paddock during a race will not be allowed to rejoin that race.

Riders returning slowly to the signalling and repair zone or paddock should take care to avoid the racing line and interfering with other riders.

Riders may groom their place behind the starting gate, without the use of any tools.

Riders may not use any starting aid devices (starting blocks, other elevating devices, etc.) at the start.

Once a rider has taken his position at the starting gate, he cannot change it, return to the waiting zone or receive assistance prior to the start.

Riders who have mechanical problems during the sighting lap and/or do not succeed into bringing their motorcycle in the waiting zone in time, will be disgualified from the race.

Riders who have mechanical problems in the waiting zone, but do not succeed in repairing their motorcycle before the entrance to the start area is closed, must remain in the waiting zone until the gate has dropped. Once the gate has dropped they can enter the starting area and resume the race. The penalty for violation of this regulation is disqualification from the race in question.

Riders having mechanical problems at the starting gate must wait for assistance until the gate has dropped. Once the gate has dropped, their mechanic(s) may assist at the gate. The penalty for violation of this regulation is disqualification from the race in question.

When crossing control lines, the rider must always be in contact with the motorcycle.

A rider who is present at a meeting and who does not take part in the practices and/or in the races and/or leaves the meeting must always inform the FIM Race Director of the reasons for his non-participation.

The riders concerned (top three positions in the overall standings in the meeting and other participants invited at the discretion of the FIM Championship Promoter) must take part in the Prize-Giving Ceremony and the Press Conference. Any infraction of this rule will be penalised.

11. Team Manager

#### 01.2.11 Team Manager

#### 01.2.11.034 FIM Motocross of Nations

Each national team is limited to one Team Manager.

A Team Manager cannot at the same time be a rider.

The Team Manager is appointed by the FMN of the team he represents.

During the meeting, the Team Manager shall be responsible for all matters regarding his team.

The FIM must be informed, in writing, of all appointments of Team Managers on the closing date of entries at the latest.

#### 1.3 MOTORCYCLES, CLASSES AND OTHER SPECIFICATIONS

1. Motorcycles and Classes

#### 01.3 MOTORCYCLES, CLASSES AND OTHER SPECIFICATIONS

#### 01.3.1 Motorcycles and Classes

Individual and Team FIM Motocross World Championship meetings are open to motorcycles as defined in the FIM Motocross World Championship Regulations, Appendix 01, FIM Motocross Technical Regulations:

- a) MX1: motorcycles of Cat. I, Group A1, over 175cc up to 250cc for 2-stroke engines and over 290cc up to 450cc for 4-stroke engines;
- MX2: motorcycles of Cat. I, Group A1, over 100cc up to 125cc for 2-stroke engines and over 175cc up to 250cc for 4-stroke engines;
- c) MX3: motorcycles of Cat. I, Group A1, over 290cc up to 500cc for 2-stroke engines and over 475cc up to 650cc for 4-stroke engines. MX1 and MX2 motorcycles may also participate in the MX3 class.

#### In addition to 01.3.1:

#### 01.3.1.032 FIM MX1/MX2 Motocross World Championships

MX1/MX2 Motocross World Championship meetings will include two classes; MX1 and MX2.

#### 01.3.1.033 FIM MX3 Motocross World Championships

MX3 Motocross World Championship meetings will include one class: MX3.

#### 01.3.1.034 FIM Motocross of Nations

The FIM Motocross of Nations will be open to three classes: MX1, MX2 and MX3.

## 1.3 MOTORCYCLES, CLASSES AND OTHER SPECIFICATIONS 2 Front Number Plate

#### 01.3.2 Front Number Plate

The motorcycle's front plate must always display (see diagrams):

- a) The background colour, in accordance with the FIM Motocross World Championship Regulations hereunder, as well as the FIM Motocross Technical Rules.
- The number of the rider, in accordance with the FIM Motocross World Championship Regulations hereunder, as well as the FIM Motocross Technical Rules;
- c) The area on the plate for a) b) and c) must have a minimum height of 200 mm and cover the complete width of the actual plate, with sufficient area to take 3 digits (ie 888) as specified in the FIM Motocross World Championship Regulations. This area is considered the front number plate;
- d) The FIM Championship logo as shown on the diagram (50 mm x 50 mm) must have a minimum clear space of 10 mm between the logo and the number and team publicity;
- e) Team publicity is allowed on the front plate within a space 50 mm from the top section of the number plate or below the number plate.

The background colours and figures vary according to the class. The following colours schemes shall be used:

- f) At the first meeting of the World Championship: a front red number plate with white numbers is compulsory for, and must be displayed by the reigning World Champion when competing in the class in which he won his World Title.
- g) From the second meeting on, a front red number plate with white numbers is compulsory for, and must be displayed by the current leader in each class of the Championship.

The following colours shall be used, following the RAL colour table, i.e.:

#### 01.3.3 Side Number Plates

The motorcycle's side number plates must always display:

The numbers must be clearly legible for the spectators and officials. Reflecting numbers are forbidden.

The following minimum dimensions must be respected on the side number plates:

The motorcycle's side number plates must always display:

- b) The FIM Championship logo (50 mm x 50 mm); and
- c) Optionally, publicity of the rider's/team's sponsor(s).

There is freedom of design and publicity, but incorporation of the rider's number and FIM Championship logo into the graphics is compulsory.

The colour scheme for the background of the side number plates and the numbers is free. However, there must be a clear colour distinction between the colour of the number and the colour of the background.

The FIM Championship logo must be in black or white.

### 1.3 MOTORCYCLES, CLASSES AND OTHER SPECIFICATIONS

#### 3. Side Number Plates

#### 01.3.3.034 FIM Motocross of Nations

The motorcycle's side number plates must always display:

b) The Team's national flag, respecting the dimensions of the number plate.

The colour scheme for the numbers on the side number plates is free. However, there must be a clear colour distinction between the colour of the number and the colour of the background/flag.

# 1.3 MOTORCYCLES, CLASSES AND OTHER SPECIFICATIONS 4. On-Board Cameras

#### 01.3.4 On-Board Cameras

When a motorcycle is equipped with on-board cameras, the weight of the camera and associated equipment will count towards the total minimum weight of the motorcycle.

These cameras and associated equipment are not considered as telemetry.

#### 1. General

#### 01.4 OFFICIALS AND PROCEDURES

#### 01.4.1 General

The management and supervision of meetings, as well as the judicial procedure, are the responsibility of the officials appointed by the FIM or the FMNs.

The FIM and the FMNs shall appoint officials whose aptitude and integrity for the position they can fully justify. These officials must be in possession of a valid FIM licence for the appropriate discipline and function.

Official's FIM licences are only issued after the officials have proved to be competent according to the special requirements for each discipline. The relevant FIM Commissions organise seminars obligatory for certain officials.

The FIM or the FMNs have the right to renew or cancel an appointment whenever necessary.

An official shall not be a rider, sponsor, team manager, mechanic or promoter participating in the meeting.

All officials and marshals must remain operative and available with all the required equipment for the meeting in place within the time limit for lodging a protest.

See also the FIM Motocross World Championship Regulations, Chapter 40 of the Sporting Code.

#### 4. FIM Representative

The FIM Management Council will appoint the FIM Representative.

If the FIM Representative is prevented from arriving at the meeting in time, the FIM will decide on his replacement.

The FIM Representative has no responsibility for the organisation of the meeting and his only duties are for representative or supervision purposes unless he is acting as a Member of the Race Direction.

The authority and duties of the FIM Representative include but are not limited to:

- The FIM Representative exercises supreme control of the meeting and is responsible for ensuring that all FIM regulations are observed.
- The FIM Representative is responsible for the communication with the Stewards.
- The FIM Representative has the right to invite any guests to the Race Direction Meetings, when appropriate.
- The FIM Representative must ensure that all parties concerned, as well as the Stewards, receive written notification of any judicial decision pronounced by the Race Direction as soon as possible.
- The FIM Representative must collate all the official reports and results of the meeting the reports and forward them together with his report to the FIM Executive Secretariat.
- At the end of the meeting, the FIM Representative, together with the Clerk of the Course, must sign the official classification of the meeting.
- The FIM Representative must send his report on the meeting, using the official FIM Report File, to the FIM Executive Secretariat within 72 hours of the finish of the meeting. This file shall contain: his report, details of any protests submitted together with the fees collected, a copy of the third party insurance, the official results, the official programme of the meeting and other official documents as requested in the file.

#### 5. FIM and FMNR Stewards

There will be a panel of three Stewards supervised by the FIM Chief Steward.

The FIM Chief Steward and FIM Steward are appointed by the FIM Management Council.

If the nominated FIM Chief Steward is prevented from arriving at the meeting in time, he will be replaced by the FIM Steward.

If the nominated FIM Steward is prevented from arriving at the meeting in time, the FIM Representative may name a replacement, with first priority given to a CMS Member not from the FMNR.

The FMNR is limited to one FMNR Steward.

Each Steward has one vote. Decisions are based upon a simple majority. In case of a tie, the FIM Chief Steward will exercise the casting vote.

The Stewards have no responsibility for the organisation of the meeting and their only duty is to give a verdict in appeals lodged against decisions of the Race Direction.

The authority and duties of the Stewards include but are not limited to:

- Ensuring that the event is conducted according to the Regulations and reporting any infringement to the Race Direction.
- Adjudicating on any appeal against the decisions of the Race Direction.
- The FIM Chief Steward must ensure that the decisions of the FIM Stewards Panel conform to the rules of the Sporting Code, to the regulations published by the FIM and the Supplementary Regulations of the meeting.
- The FIM Chief Steward must ensure that all parties concerned, as well as the Race Direction, receive written notification of any judicial decision pronounced by the Stewards as soon as possible.

#### 6. Event Management

The Event Management is composed of the FIM Race Director, a Representative of the FIM Championship Promoter, as well as a Representative from the respective Organiser.

The FIM Race Director and the Representative of the FIM Championship Promoter each have voting right. The Representative from the respective Organiser has no voting right. The Representative of the FIM Championship Promoter will exercise a casting vote.

The Event Management will manage the meeting and is:

- To ensure the smooth and efficient running of the meeting.
- To make recommendations to the Race Direction to improve the smooth and efficient running of the meeting.
- To bring to the attention of the Race Direction any matter that is in contradiction to the Regulations.
- To report to the Race Direction any infringements of the Regulations.

The meetings of the Event Management are chaired by the Representative of the FIM Championship Promoter.

The Event Management will meet at any time required during the meeting, but at least:

- At the end of the first day of the meeting (= the day when the administrative control and the technical verifications start).
- At the end of each following day.
- At the end of the meeting.

#### 7. Race Direction

The Race Direction is composed of the FIM Representative, the FIM Race Director and the Clerk of the Course

Each Member has one vote. Decisions are based upon a simple majority. In the case of a tie, then the FIM Representative will exercise a casting vote.

The quorum for a meeting of the Race Direction is three persons.

The meetings of the Race Direction are chaired by the FIM Representative.

The Race Direction will meet at any time required during the meeting.

The Race Direction has the competence to pronounce **ex officio** sanctions against riders, team staff, officials, promoters/organisers and all the persons involved in any capacity whatsoever in a meeting or in the Championship.

The duties of the Race Direction are:

- To impose penalties for any infringements of the Regulations.
- To impose penalties for any voluntary or involuntary action or deed accomplished by a person or a group of persons during a meeting, contrary to the current Regulations or instructions given by an official of the meeting.
- To impose penalties for any corrupt or fraudulent act, or any action prejudicial to the interests of the meetings or of the sport, carried out by a person or a group of persons occurring during an event.
- To impose penalties on organisers for having been unable to ensure the smooth and efficient running of the event or for serious breaches of the Regulations.
- To adjudicate on any protest relating to infringements of the Regulations.

#### 7. Race Direction

The Race Direction may pronounce the following penalties provided for in the FIM Disciplinary and Arbitration Code, without prejudice to Art. 2.2 and 2.3 of the of the same Code:

- warnings
- fines, subject to a maximum of USD 4'000.-
- time and/or point penalties
- disqualification
- suspension for a period not exceeding 30 days starting from the date of the offence

or refer the case to the International Disciplinary Court to impose a higher penalty that it is empowered to.

Any person or organisation affected by a disciplinary decision of the Race Direction has the right to appeal this decision. This appeal must be presented to the Race Direction 60 minutes at the latest after the notification of that decision.

Appeals against a disciplinary decision taken by the Race Direction will be dealt with by the FIM Stewards Panel.

The FIM Stewards Panel is composed of the FIM Chief Steward, the FIM Steward and the FMNR Steward.

Each Member has one vote. Decisions are based upon a simple majority. In the case of a tie, then the FIM Chief Steward will exercise a casting vote.

The quorum for a meeting of the FIM Stewards Panel is three persons.

The meetings of the FIM Stewards Panel are chaired by the FIM Chief Steward.

The FIM Stewards Panel will meet at any time required during the meeting.

The FIM Stewards Panel will hear any appeals against decision of the Race Direction.

The FIM Stewards Panel may pronounce the following penalties provided for in the FIM Disciplinary and Arbitration Code, without prejudice to Art. 2.2 and 2.3 of the of the same Code:

- warnings
- fines, subject to a maximum of USD 4'000.-
- time and/or point penalties
- disqualification
- suspension for a period not exceeding 30 days starting from the date of the
  offence.

or refer the case to the International Disciplinary Court to impose a higher penalty that it is empowered to.

If the decision of the FIM Stewards Panel confirms the decision of the Race Direction, no appeal can be lodged to the CDI. In this case, the decision of the FIM Stewards Panel is final.

#### 8. FIM Stewards Panel

If the decision of the FIM Stewards Panel does not confirm the decision of the Race Direction, an appeal may be lodged to the CDI. This appeal must be presented 5 days at the latest after the notification of the FIM Stewards Panel decision. The decision of the CDI is final.

After exhaustion of the FIM internal instances, an appeal to the CAS is still possible. This appeal must be presented 5 days at the latest after the notification of the final decision.

9. Jury President, Jury Members and Observers

#### 01.4.9 Jury President, Jury Members and Observers

#### 01.4.9.033 FIM MX3 Motocross World Championships

The President and CMS Jury Member will be appointed by the Commission or by the Management Council.

If the nominated Jury President is prevented from arriving at the meeting in time, he will be replaced until his arrival by the Jury Member appointed by the FIM.

If the nominated CMS Jury Member is prevented from arriving at the meeting in time, the Jury President may name a replacement, with first priority given to a CMS Member not from the FMNR.

The FMNR is limited to one Jury Member.

One representative each of the FIM Championship Promoter and the Motorcycle Manufacturers will be admitted as observers to the International Jury meetings.

The authority and duties of the Jury President are:

- The Jury President shall determine the times of the Jury meetings and, if necessary, convene any extraordinary meetings.
- The Jury President shall call a meeting of the Jury before the first official practice session.
- At the end of each day of official practice, the Jury President will call a meeting of the International Jury to hear the reports of the Clerk of the Course, the Secretary to the Jury and any other appropriate officials.
- At the end of the meeting, during the last meeting of the International Jury, the Jury President, together with the Clerk of the Course, must sign the official classification of the meeting. He must also sign with the Secretary to the Jury all Minutes of the Jury meetings.
- The Jury President must ensure that the decisions of the International Jury conform to the rules of the Sporting Code, to the regulations published by the FIM and the Supplementary Regulations of the meeting.

# 1.4 OFFICIALS AND PROCEDURES 9. Jury President, Jury Members and Observers

- The Jury President has the right to invite any guests to the Jury meetings, if appropriate for the meeting or the Championship.
- The Jury President is responsible for the communication with the FMN Delegates.
- If necessary, the Jury President will arrange a meeting with FMN Delegates in order to explain the work of the International Jury and to receive the remarks of the FMN Delegates.
- The Jury President must send his report on the meeting, using the official Jury President's Report File, to the FIM Executive Secretariat within 72 hours of the finish of the meeting. This file shall contain: his report, details of any protests submitted together with the fees collected, a copy of the third party insurance, the official results, the official programme of the meeting and other official documents as requested in the file.

See also the FIM Motocross World Championship Regulations, Sporting Code.

# 1.4 OFFICIALS AND PROCEDURES 10. Jury Meetings

01.4.10 Jury Meetings

#### 01.4.10.033 FIM MX3 Motocross World Championships

During the first Jury meeting, the International Jury shall approve the following matters:

- Amendments, if any, to the SR after the opening date for entries verifying that all the riders and participants engaged have been informed thereof;
- Report of the Secretary to the Jury stipulating that officials with any responsibility for the running of the meeting are in possession of their respective licences and authorisations;
- Report of the Secretary of the Jury stipulating that all riders and participants entered have duly completed the official FIM Motocross World Championship entry form and that they are in possession of their respective licences and authorisations from their FMN.
- Report from the Clerk of the Course showing all steps to be taken to ensure the orderly running of the meeting;
- Report and control of the safety standards of the meeting;
- Control and approve any amendments of requests of extra safety measures as mentioned in the inspection report;
- Control of the official permission from the local authorities to run the meeting and of the third party insurance policy of the organiser.

The International Jury will hear any protests that are lodged during the meeting.

#### 1.4 OFFICIALS AND PROCEDURES 10. Jury Meetings

The International Jury may pronounce the following penalties provided for in the FIM Disciplinary and Arbitration Code, without prejudice to Art. 2.2 and 2.3 of the of the same Code:

- warnings
- fines, subject to a maximum of USD 4'000.-
- time and/or point penalties
- disqualification
- suspension for a period not exceeding 30 days starting from the date of the offence.

or refer the case to the International Disciplinary Court to impose a higher penalty that it is empowered to.

An appeal against the decision of the International Jury may be lodged to the CDI. This appeal must be presented 5 days at the latest after the notification of the International Jury decision.

After exhaustion of the FIM internal instances, an appeal to the CAS is still possible. This appeal must be presented 5 days at the latest after the notification of the final decision.

# 1.4 OFFICIALS AND PROCEDURES 11. Minutes of the Jury Meetings

#### 01.4.11 Minutes of the Jury Meetings

#### 01.4.11.033 FIM MX3 Motocross World Championships

The Minutes of all the Jury meetings must be written in both official FIM languages, unless the International Jury is agreeable to accepting them in one official language.

The Minutes must state in detail any penalties imposed, the decisions taken concerning any protests received (copies of which must be attached), the details of any accidents which may have occurred, any possible irregularities observed, as well as the opinion of the International Jury regarding the success of the organisation and any possible remarks they consider to be worthy of special mention.

The Minutes are to be prepared by the Secretary to the Jury and must be signed by him and the Jury President.

A copy of these Minutes must be sent to the FIM Executive Secretariat within 72 hours after the meeting.

# 1.4 OFFICIALS AND PROCEDURES 12. Publication of Jury Decisions

#### 01.4.12 Publication of Jury Decisions

#### 01.4.12.033 FIM MX3 Motocross World Championships

All decisions of the International Jury necessary for the running of the meeting as well as the results must be published as soon as is reasonably possible. These decisions must be published in the official languages of the FIM.

Any judicial decision pronounced by the International Jury must be notified directly at the venue of the meeting or, failing that, by registered letter with acknowledgement of receipt.

Whenever possible at the meeting, the party (parties) involved should at least be notified orally. However, it is preferable that the decision of the International Jury be notified by a written document.

This document/International Jury decision shall:

- State the names and the licence numbers of the Jury President and the CMS and FMNR Jury Members;
- State the name(s) of the party (parties) involved;
- In case of a protest, state that the protest fee has been paid by the protesting party;
- State the reasons for the action taken/protest;
- State the articles to which the action taken/protest relates;
- State any additional information obtained during the hearing;
- State the decision of the International Jury and its evidence and brief reasons:
- Be signed by the President and the CMS and FMNR Members of the International Jury.

# 1.4 OFFICIALS AND PROCEDURES 12. Publication of Jury Decisions

Whenever the party (parties) involved is (are) notified in writing at the meeting, the following procedure must be respected:

- The party (parties) concerned by the International Jury decision must sign for receipt on a copy of the International Jury decision/ acknowledgement of receipt.
- The name of the person who receives the decision. His position/function, the venue, date, time of reception must also be mentioned on this acknowledgement of receipt.
- The copy of the International Jury decision, signed for receipt by the party (parties) concerned, must be added to the Report of the Jury President.

# 1.4 OFFICIALS AND PROCEDURES 13. FMN Delegates

#### 01.4.13 FMN Delegates

#### 01.4.13.033 FIM MX3 Motocross World Championships

Each FMN which has a rider participating in the meeting is entitled to be represented by a national Delegate, holder of a Sporting Steward's licence.

Each FMN and the FMNR is limited to one Jury Delegate.

All such nominations must be submitted in writing to the FMNR. The FMNs must inform the FMNR of the name of their Delegate not less than 15 days prior to the meeting.

The duties and the rights of the FMN/FMNR Delegate are:

- The FMN/FMNR Delegate represents his FMN and the riders entered by that FMN.
- The FMN/FMNR Delegate may attend the open meetings of the Jury, as an observer.
- The FMN/FMNR Delegate must explain his questions to the Jury President so that the International Jury is aware of all circumstances.
- The FMN/FMNR Delegate is entitled to receive passes to be present and to be able to carry out his duties during the meeting.
- During the entire meeting, the FMN/FMNR Delegate is entitled to receive documents related to the meeting, including the Jury Minutes.

# 1.4 OFFICIALS AND PROCEDURES 14. FIM Race Director

#### 01.4.14 FIM Race Director

The FIM will appoint the FIM Race Director.

The FIM Race Director has no responsibility for the organisation of the meeting and his only executive duties are those defined in these regulations.

The authority and duties of the FIM Race Director include but are not limited to:

- The FIM Race Director must be present at least 24 hours before the start of practice and remain after the meeting until the completion of his duties.
- The FIM Race Director must inspect the circuit and safety installations before practice begins (= circuit control).
- The FIM Race Director may make recommendations which affect or vary from the published programme, such as the re-running of a race, the disqualification of a rider, the duration of a race, or the postponement, stopping or abandonment of the meeting.
- In exceptional circumstances, the FIM Race Director may on his own initiative reduce the duration of a Free or Time Practice session, a Qualification Race, a Last Chance Qualifying Practice or a Race.

#### In addition to 01.4.14:

## 01.4.14.032 FIM MX1/MX2 Motocross World Championships 01.4.14.034 FIM Motocross of Nations

If the FIM Race Director is prevented from arriving at the meeting in time, the FIM Representative will decide on his replacement.

The only duties of the FIM Race Director are for representative or supervision purposes when he is acting as a Member of the Race Direction.

## 1.4 OFFICIALS AND PROCEDURES 14 FIM Race Director

The authority and duties of the FIM Race Director also include:

- The FIM Race Director is responsible for all communications between the Event Management and the Race Direction.
- The FIM Race Director may make his recommendations to the Race Direction.

#### 01.4.14.033 FIM MX3 Motocross World Championship

If the FIM Race Director is prevented from arriving at the meeting in time, the Jury President will decide on his replacement.

The authority and duties of the FIM Race Director also include:

- The FIM Race Director exercises supreme control of the meeting and is responsible for ensuring that all regulations are observed.
- The FIM Race Director may make his recommendations to the International Jury.

# 1.4 OFFICIALS AND PROCEDURES 15. Clerk of the Course

01.4.15 Clerk of the Course

01.4.15.032 FIM MX1/MX2 Motocross World Championships
01.4.15.034 FIM Motocross of Nations

The Clerk of the Course is appointed by the FMNR.

The Clerk of the Course cannot be at the same time the FMNR Steward.

The Clerk of the Course shall act and work in permanent consultation with the FIM Race Director.

The Clerk of the Course is responsible for the conduct and efficient running of the meeting. His essential duties include but are not limited to:

- The Clerk of the Course must certify that official permissions from the local authorities to run the meeting have been granted to the organiser.
- The Clerk of the Course must present a copy of the third party insurance policy of the organiser to the FIM Representative.
- The Clerk of the Course must ensure that the circuit, track or venue is in good condition, that all officials are present and ready to carry out their functions and that the safety, medical and control services are on duty.
- The Clerk of the Course must verify the identity of the riders, the correct numbering of the motorcycles, and that there is nothing to prevent a rider from participating in the meeting, e.g. injury, suspension, disqualification, or any other ban on riding (According to information given by the FIM Executive Secretariat or the FIM Championship Promoter).
- The Clerk of the Course can postpone the start of a meeting for an urgent case of safety or for any other case of "force majeure" or proceed with the improvement of the conditions of the circuit, track or venue, stop a meeting prematurely or cancel part of or the entire meeting.

## 1.4 OFFICIALS AND PROCEDURES 15. Clerk of the Course

- The Clerk of the Course can prevent a rider or a motorcycle from starting, or order their withdrawal from the meeting if he considers such action necessary for safety reasons.
- The Clerk of the Course must ensure that the FIM rules are respected; he may propose penalties to the Race Direction.
- The Clerk of the Course can order the removal from the circuit, track or venue and its vicinity of any person refusing to obey the orders of an official in charge.
- The Clerk of the Course must notify the Race Direction of all decisions to be taken or already taken, and of any protest handed over to him.
- The Clerk of the Course must collate the reports and results from all officials and all other information necessary to present his report to the Race Direction, and to have the provisional results of the meeting approved.

#### 01.4.15.033 FIM MX3 Motocross World Championship

The Clerk of the Course cannot be a voting member of the International Jury.

The Clerk of the Course is appointed by the FMNR.

The Clerk of the Course shall act and work in permanent consultation with the FIM Race Director.

The Clerk of the Course is responsible for the conduct and efficient running of the meeting. His essential duties are:

- The Clerk of the Course must ensure that the circuit, track or venue is in good condition, that all officials are present and ready to carry out their functions and that the safety, medical and control services are on duty.
- The Clerk of the Course must verify the identity of the riders, the correct numbering of the motorcycles, and that there is nothing to prevent a rider from participating in the meeting, e.g. suspension, disqualification or any other ban on riding (According to information given by the FIM Executive Secretariat or the FIM Championship Promoter).

## 1.4 OFFICIALS AND PROCEDURES 15. Clerk of the Course

## 1.4 OFFICIALS AND PROCEDURES 16 Technical Steward

#### 01.4.16 Technical Steward

The Technical Steward, appointed by the FMNR, shall in particular:

- Verify the machines and equipment in accordance with the FIM Regulations and the Supplementary Regulations.
- Draw up a technical report and hand a copy to the Clerk of the Course.

#### In addition to 01.4.16:

#### 01.4.16.032 FIM MX1/MX2 Motocross World Championships 01.4.16.034 FIM Motocross of Nations

 If requested to do so by the Race Direction, attend meetings, but without voting rights.

#### 01.4.16.033 FIM MX3 Motocross World Championship

 If requested to do so by the President of the International Jury, attend meetings, but without voting rights.

#### 17. Timekeeper

#### 01.4.17 Timekeeper

Appointed timekeepers shall in particular:

- Be qualified to use the timekeeping system of the meeting.
- If requested to do so by the riders, examine their results and show them the recording of their lap times.
- Produce the official results in accordance with the FIM Regulations and hand a copy to the Clerk of the Course.

#### In addition to 01.4.17:

The Timekeepers are appointed by the FIM Championship Promoter and shall additionally:

The Timekeepers are appointed by the FMNR and shall additionally:

 If requested to do so by the President of the International Jury, attend meetings, but without voting rights.

## 1.4 OFFICIALS AND PROCEDURES 18 Environmental Steward

#### 01.4.18 Environmental Steward

The Environmental Steward, appointed by the FMNR, shall be responsible for all environmental aspects and shall in particular:

- Ensure that the FIM Environmental Code is respected.
- Report to the Clerk of the Course any infringement to the FIM Environmental Code.
- Have access to all information concerning the meeting, and be able, prior, during and after the meeting, to give recommendations on all aspects of the meeting which may have potential environmental consequences.
- Draw up a report on the basis of a check-list prepared by the relevant Commission and send it to the FIM Executive Secretariat and hand a copy to the Clerk of the Course.

#### In addition to 01.4.18:

- Give his recommendations to the Event Management.
- If requested to do so by the Race Direction, attend meetings, but without voting rights.

### 01.4.18.033 FIM MX3 Motocross World Championship

- Give his recommendations to the International Jury.
- Be entitled to attend all open meetings of the International Jury, but without voting rights.

## 1.4 OFFICIALS AND PROCEDURES 19. Chief Medical Officer

#### 01.4.19 Chief Medical Officer

The Chief Medical Officer, appointed by the FMNR, shall be responsible for all medical aspects and shall, in particular:

- Ensure that the FIM Medical Code is respected.
- Inspect all medical/paramedical services not less than 30 minutes before the start of practice and racing each day of the meeting.
- Ensure that all medical/paramedical services and staff are in their correct places and ready to function.
- Ensure that all medical/paramedical services are briefed prior to the first practice session, as well as debriefed after the meeting.
- Give information and recommendations on injured riders and all aspects of the meeting which may have potential medical consequences.
- Draw up a report on the basis of a check-list prepared by the relevant Commission and hand a copy to the Clerk of the Course.

#### In addition to 01.4.19:

#### 01.4.19.032 FIM MX1/MX2 Motocross World Championships 01.4.19.034 FIM Motocross of Nations

- Give his information and recommendations to the Race Direction.
- If requested to do so by the Race Direction, attend meetings, but without voting rights.

### 01.4.19.033 FIM MX3 Motocross World Championship

- Give his information and recommendations to the FIM Race Director, the International Jury and the Clerk of the Course.
- Attend all meetings of the International Jury, but without voting rights.

# 1.4 OFFICIALS AND PROCEDURES 20. Flag Marshals

#### 01.4.20 Flag Marshals

The minimum age for Flag Marshals is 16 years. They are appointed by the FMNR/organiser and must have participated in a briefing with the Clerk of the Course.

For each Flag Marshal's post, the Organiser must establish a list with the names of the marshals occupying the post.

The marshals must be identified by uniform shirts or bibs of a neutral colour, in no case yellow or red, so that they cannot be confused with the flags.

There must be a minimum of two marshals per post: one Flag Marshal (using a flag) and one marshal (without a flag) to give assistance to a rider in the interests of safety. One or more additional marshals are recommended at jumps.

After a meeting, the Flag Marshals must remain available until protest time has expired.

The list with the names of the marshals is to be given to the Clerk of the Course, who will hand it over to the FIM Representative.

The list with the names of the marshals is to be given to the International Jury before the first Jury Meeting.

# 1.4 OFFICIALS AND PROCEDURES 21. Official Signals

### 01.4.21 Official Signals

Official board signals shall be given by means of a white board measuring 750 mm high by 600 mm wide, with a black block number 10', 4', 15" and 5" on both sides. The numbers shall measure 500 mm in height.

#### 1 Administrative Control

#### 01.5 RUNNING OF THE MEETING

#### 01.5.1 Administrative Control

Riders entered in a meeting may be required to present their FIM Motocross World Championship licence, starting permission from their FMN, and/or to sign an individual entry form during an administrative control carried out by the FIM/FMNR/Organisers and/or the FIM Championship Promoter.

It is necessary to confirm whether all the riders present at the meeting:

- 1) Are in possession of a valid FIM Motocross World Championship licence;
- 2) Have been authorised by their FMN to participate in that meeting;
- Have duly completed the official FIM Motocross World Championship entry form.

#### In addition to 01.5.1:

#### 01.5.1.032 FIM MX1/MX2 Motocross World Championships

The FIM Championship Promoter must prepare an updated entry list and give it to the Clerk of the Course before the start of the administrative control.

The FIM Championship Promoter must also verify that there is nothing to prevent a rider from participating in the meeting, e.g. injury, suspension, disqualification, or any other ban on riding.

The report (confirmation) of administrative control must be presented to the Race Direction by the representative of the FIM Championship Promoter before the start of the official practices of the meeting.

### 01.5.1.033 FIM MX3 Motocross World Championship

The FIM Championship Promoter must prepare an updated entry list and give it to the Clerk of the Course before the start of the administrative control.

#### 1. Administrative Control

The FIM Championship Promoter must also verify that there is nothing to prevent a rider from participating in the meeting, e.g. injury, suspension, disqualification, or any other ban on riding.

The report (confirmation) of administrative control must be presented to the International Jury by the **representative of FIM Championship Promoter** at the first Jury Meeting.

#### 01.5.1.034 FIM Motocross of Nations

The FIM Executive Secretariat must prepare an updated entry list and give it to the Clerk of the Course before the start of the administrative control.

The FIM Executive Secretariat must also verify that there is nothing to prevent a rider from participating in the meeting, e.g. injury, suspension, disqualification, or any other ban on riding.

The report (confirmation) of administrative control must be presented to the Race Direction by the FIM Executive Secretariat before the start of the official practices of the meeting.

#### 1.5 RUNNING OF THE MEETING 2 FIM Laissez-Passer

#### 01.5.2 FIM Laissez-Passer

The FIM MX1, MX2, MX3 Motocross World Championships and the FIM Motocross of Nations are covered by a contract signed by the FIM.

Therefore, and for security and practical reasons, only passes issued by the FIM Contractual Partner are valid.

FIM laissez-passer, Manufacturers' Licences, Accessory Manufacturers' Licences and Sponsors' Licences, issued for the personal use of company employees or those persons authorised by the latter, are not valid.

#### 3. Preliminary Technical Verifications

#### 01.5.3 Preliminary Technical Verifications

Prior to practice, a technical control must be carried out in accordance with the procedure and the times fixed in the FIM Motocross World Championship Regulations and/or the Supplementary Regulations of the meeting.

The technical verifications must be held on the site of the meeting.

During these technical verifications, a rider may be required to provide and sign a written declaration asserting the conformity of certain parts of his motorcycle.

During the meeting and per class, riders are allowed to use only those motorcycles (maximum two) presented at scrutineering.

Each rider must present one motorcycle in his name and number at scrutineering. There are two possibilities for a second motorcycle, which must be of the same make, type and cylinder capacity as the first one:

- Riders may present at scrutineering a second motorcycle in their name and number;
- 2) Teams may present at scrutineering a second motorcycle to be used by two or more riders. In this case, the team presenting the motorcycle, must inform the Technical Stewards of the names and numbers of the riders eligible to use this motorcycle;

For the initial sound control and technical inspection, a rider (or his mechanic) shall present only one spare silencer per machine. Other spare silencers may be presented after all participants have presented their motorcycles, or on the following days of the meeting.

Riders may change motorcycles at any time except during a race.

The final choice of motorcycle to be used in a race must be made 10 minutes before the start of the race in question.

#### 3. Preliminary Technical Verifications

At any time during the meeting:

- On request of the Technical Steward, a rider must present himself and/or their motorcycle(s) and/or equipment to the technical verification;
- A rider will be responsible for keeping his motorcycle and/or equipment in conformity with the rules.

At any time during the meeting:

#### 4. Special Medical Examination

Any rider who refuses to submit himself to such special medical examination shall be disqualified from the meeting, and his case notified to his FMN and to the FIM for the possible application of a penalty.

A meeting with the organisers will be held on Friday, generally at 17:00, after the circuit control

The FIM Race Director, the Clerk of the Course, representatives of the organiser and an FMNR representative are expected to attend.

Also invited to attend this meeting are: the Secretary of the Meeting, the Chief Timekeeper and the Chief Scrutineer, the Environmental Steward, the Paddock Marshal, the Chief Flag Marshal, the Chief Medical Officer, the Press Officer, representatives of the World FIM Championship Promoter, etc.

If the Chief Medical Officer is not present, the organiser must be prepared to discuss the medical installations and evacuation plan for the meeting.

# 1.5 RUNNING OF THE MEETING 7. Filming with On-Board Cameras

#### 01.5.7 Filming with On-Board Cameras

Riders may be required by the FIM Championship Promoter to carry on-board cameras on their motorcycles.

When a motorcycle is equipped with on-board cameras, the cameras and associated equipment must be carried during the entire meeting, from the practice sessions until the end of the meeting.

Cameras and other equipment will be supplied to the designated riders/teams no later than 2 hours before the first practice.

Riders/teams must give reasonable access and assistance to the designated technicians to facilitate mounting and adjustment of the equipment.

#### 8. Practice / Practice Restrictions

#### 01.5.8 Practice / Practice Restrictions

Pre-meeting practice on a FIM Motocross World Championship meeting circuit by riders competing in the Championship in question is prohibited within 30 days of the date of the meeting, unless the FMNR, the organiser and the riders receive prior written approval from the FIM and the FIM Championship Promoter.

Riders and team members are forbidden to ride any motorised vehicle and/or bicycle on the track outside the official practice/gualifying sessions and races.

#### 9. Practice / Free Practice

#### 01.5.9 Practice / Free Practice

The official Free Practice sessions of a FIM World Championship meeting are part of that meeting and cannot be considered pre-meeting practices.

#### In addition to 01.5.9:

#### 01.5.9.032 FIM MX1/MX2 Motocross World Championships

In each class, up to 40 riders may take part in the Free Practices.

#### 01.5.9.033 FIM MX3 Motocross World Championship

Two Free Practice sessions must be provided.

If there are more than 50 riders, the riders will be allocated to Groups "A" and "B" by ballot.

## a) For the first meeting of the season:

The riders will be allocated to Groups "A" and "B" according to their standings in the previous year's FIM MX3 Motocross World Championship and presence at the meeting: the best rider present will be allocated to Group "A", the second best rider present to Group "B", the third best rider present to Group "A", and so on. A ballot will decide upon the riders having no overall places from the previous year's FIM MX3 Motocross World Championship.

## b) As of the second meeting of the season:

The riders will be allocated to Groups "A" and "B" upon their standings in the current year's FIM MX3 Motocross World Championship and presence at the meeting: the best rider present will be allocated to Group "A", the second best rider present to Group "B", the third best rider present to Group "A", and so on. A ballot will decide upon the riders having no overall places from the current year's **FIM MX3 Motocross World Championship**.

## 1.5 RUNNING OF THE MEETING 9. Practice / Free Practice

The International Jury and the Clerk of the Course will proceed with the ballot after Saturday morning's technical verifications and before the First Jury Meeting.

Should there be an odd number of riders to divide, Group "A" will consist of one more rider than Group "B".

Changing group is forbidden.

#### 01.5.9.034 FIM Motocross of Nations

For each class (MX1, MX2 and "Open"), one separate Free Practice session of 40 minutes must be provided.

The maximum number of riders in each Free Practice session is 40.

Riders may not change Group.

A briefing with the riders may be held at the starting gate, generally on Saturday.

The FIM Race Director, the Clerk of the Course, the Chief Flag Marshal, the organisers, the FIM Championship Promoter, the industry representative, the team managers and all riders participating in the meeting should attend.

The Secretary of the Meeting and the Chief Medical Officer may also attend this briefing.

During this briefing, matters relating to the circuit and safety and race procedures will be discussed.

After the briefing, there will be a demonstration of the complete start procedure.

It is the responsibility of each rider and team to attend the briefing, be aware of all information given and follow all instructions issued.

#### 01.5.11 Qualifying

Qualifying in each class will involve a Pre-Qualifying Practice and a Qualifying Race. Up to 40 riders may take part.

Riders must always start Pre-Qualifying Practice from the waiting zone.

Riders will qualify for their starting positions in the Qualifying Race according to their best result in the Pre-Qualifying Practice. In case of ties, the second best times will be taken into consideration.

If, for unforeseen reasons, a rider does not score any qualification time in the Pre-Qualifying Practise, he will be placed last on the starting grid for the Qualifying Race. If several riders are concerned, the times set in Free Practice will be taken in consideration. Should there still be riders without any times after this procedure, then a ballot will decide upon their starting position.

If the **Pre-Qualifying Practice** is cancelled for any reason, times from the **Free Practice** will be used as qualifying times **for the Qualifying Race**.

If, for unforeseen reasons, no qualification results are obtained before the Warm-Up, then the latter may be treated as a **Qualifying session for the Grand Prix Races**. The Race Direction will decide upon any modifications to the time schedule and qualifying criteria.

#### 01.5.11.033 FIM MX3 Motocross World Championship

All the riders present at the meeting must take part in the Qualifying Practice.

Qualifying in the FIM MX3 class will be solely through Qualifying Practice.

The riders will qualify according to their best result in the Qualifying Practices. In case of ties, the second best times will be taken into consideration.

The fastest 40 riders will qualify for the FIM MX3 Motocross World Championship Races

If, for unforeseen reasons, no qualification results are obtained before the Warm-Up, then the latter may be treated as Qualifying Practices. In collaboration with the FIM Race Director, the International Jury will decide upon any modifications to the time schedule and qualifying criteria.

The format of the Qualifying Practices will depend upon the number of riders present at the meeting:

In both cases, the best two results of each team will be taken into account, irrespective of class.

In case of a tie, the best result of the third rider will be taken into account.

If a tie still exists, the best result of firstly the MX1, secondly the MX2 or thirdly the "Open" class will be taken into account.

If one Qualifying Race is cancelled for any reason, the results from the two other Qualifying Races will be counted to determine the team's qualifying position. In case of a tie with another team, the best result of one of the two riders will be taken into account. If a tie still exists, the best result of firstly the MX1, secondly the MX2 or thirdly the "Open" class will be taken into account.

If two Qualifying Races are cancelled for any reason, the results from the one Qualifying Race that has been run will be used to determine the team's qualifying position. This result will be counted together with the best lap time position of any of its two remaining riders in the Free Practice session. If the B-Final is cancelled for any reason, the remaining non-qualified teams will be classified according to their result in Qualifying. The first non-qualified team will then be designated the 20th team to qualify for the FIM Motocross of Nations.

If, for unforeseen reasons, no qualification results are obtained before the Warm-Up, then the latter may be treated as qualifying session. The Race Direction will decide upon any modifications to the time schedule and qualifying criteria.

Once a rider has taken his position at the starting gate, he cannot change it, return to the waiting zone or receive assistance prior to the start.

When all riders are on the starting line, a green flag will be displayed.

Upon a signal from the FIM Race Director:

- A "15 seconds" sign will be displayed from which moment the riders are under the starter's orders. The "15 seconds" sign will be displayed for 15 full seconds.
- At the end of 15 seconds, a "5 seconds" sign will be displayed and the gate will drop between 5 and 10 seconds after the "5 seconds" sign is shown.

An Official will order the release of the starting gate.

# 1.5 RUNNING OF THE MEETING 19 Start Procedure

Whenever it is not possible to start the race by means of the starting gate, a green flag will be used to give the start.

The same start procedure (as mentioned above) will be maintained until 15 seconds before the start of the race.

The FIM Race Director moves to the side of the track, holding up the green flag. He then puts down the green flag upon which the race starts.

The area in front of the starting gate shall be prepared in a consistent manner providing conditions as equal as possible for all riders. No one except the essential officials, TV camera crews and photographers shall be allowed in this area. No grooming of the area is permitted.

- b) If they are admitted to the race, the reserve riders leave the reserve area and proceed to the starting gate in order of priority.

# 1.5 RUNNING OF THE MEETING 20. Starting Order

If, for unforeseen reasons, no qualification results are obtained in one or more classes before the Races, then the International Jury, in collaboration with the FIM Race Director, will decide upon the qualifying criteria and starting order. However, the same principle will be maintained.

# 1.5 RUNNING OF THE MEETING 23. Stopping of a Race

#### 01.5.23 Stopping of a Race

The FIM Race Director is authorised to prematurely stop any part of the meeting for urgent and/or safety reasons or other cases of "force majeure". In that case, a red flag will be displayed to the riders:

#### 1. Before 2 laps have elapsed

If a Qualifying Race or a Race is stopped before 2 laps have elapsed, there will be a complete restart. Riders will have to go back to the waiting zone and the restart will take place as soon as possible.

Changing of motorcycles will not be allowed.

If one or more riders are deemed to be at fault for the race being stopped, they may be excluded from taking part in the restart.

No reserve riders (if any) will be introduced.

#### 2. After 2 laps have elapsed

If a Qualifying Race is stopped before 10 minutes have elapsed or if a Race is stopped before 20 minutes have elapsed, there will be a complete restart. Riders will return to the paddock and the restart will take place 30 minutes after the red flag was displayed.

Changing of motorcycles will be allowed. The final choice must be made 10 minutes before the restart.

If one or more riders are deemed to be at fault for the race being stopped, they may be excluded from taking part in the restart.

Reserve riders (if any) may take part in the restart of a Race if one or more of the original starters are unable to take part or are disqualified

# 1.5 RUNNING OF THE MEETING 23. Stopping of a Race

If a Race is stopped after 20 minutes have elapsed, the race will be completed. In that case, the riders' placings will be those at the end of the lap preceding the stopping of the race.

In the case of the stopping of a Race after 20 minutes have elapsed, full championship points will be awarded.

Immediately after each Race, three motorcycles, chosen at random, may be checked for compliance with noise regulations. Other motorcycles may also be checked.

Any rider whose motorcycle is above the maximum allowed post-race limit of:

- dB/A 96 (dB/A 94 + 2 for motorcycles with a four-stroke engine;
- dB/A 98 (dB/A 96 + 2 for motorcycles with a two-stroke engine;
- whether it be one of the riders chosen at random or any other rider whose motorcycle is controlled/verified - will be penalised by having one minute added to his riding time in the race in question. Once one minute has been added, the rider will then be classified with the riders who have an equal number of laps according to his time.

Subject to rules governing outside assistance, riders may freely change their silencers but their motorcycles must be checked for compliance. Therefore the Technical Steward and his equipment must be available throughout the meeting.

All official outings of the riders on the circuit (see Art. 01.1.3 Format of the Meeting) must be timed, with the results displayed on monitors and communicated to the press.

Timing shall continue until:

- 5 minutes after the end of each practice or timed qualifying session;
- 5 minutes after the arrival of the winner of the race in question.

The winner of a race is the rider who crosses the finish line first.

Races are officially ended at the completion of the lap at which the chequered flag is displayed to the winner.

The riders who follow the winner will then be stopped when crossing the finishing line.

The time at which a motorcycle crosses a control line shall be registered at the moment the foremost part of the motorcycle crosses the line.

When crossing control lines, the rider must always be in contact with the motorcycle.

All the riders participating in the Qualification Race and/or Race will be classified in order of finish and number of laps completed; i.e. all riders finishing on the same lap as the winner will be classified in the order they cross the finish line, followed by riders with one less lap, then two laps and so on. Riders must cross the finish line within 5 minutes of the arrival of the winner, i.e. riders have 5 minutes to complete the lap or it will not be counted in their result. The procedure to determine the classification in the results of riders who do not complete the lap within 5 minutes after the arrival of the winner will be according to the number of laps completed, and in the event of a tie, according to their finishing order at the end of the preceding lap.

If the chequered flag is mistakenly displayed later than the official time/distance, the finishing order shall be determined by the running order at the official time/distance.

#### 1.5 RUNNING OF THE MEETING 25. Results / Procedure

Under any other circumstances, such as mistaken display of the chequered flag before the official time/distance, the finishing order shall be determined by the running order at the time the chequered flag is displayed.

All results must be homologated.

The results will not become official until the time limits for protests have elapsed.

If a protest is lodged, the results will not become official until a decision is taken by the competent body.

Any other protests must be lodged immediately after the reason for the protest is known.

Protests against results must be presented within 30 minutes following the announcement of the results.

Protests must be lodged according to the FIM Disciplinary and Arbitration Code and the Supplementary Regulations of the meeting and be accompanied by a fee of US\$ 800.– (€ 640.–) or the equivalent amount in local currency, returnable if the protest is justified.

If the protest entails dismantling a motorcycle, the protest fee must be accompanied by an additional deposit of US\$ 150.– (€ 120.–). This fee must be paid by the losing party to the mechanic of the rider who had to open the engine.

Protests entailing a fuel control must be accompanied by an additional deposit of US\$ 1'000.− (€ 800.−).

After exhaustion of the FIM internal instances, an appeal to the CAS is still possible. This appeal must be presented 5 days at the latest after the notification of the final decision.

#### 1.5 RUNNING OF THE MEETING 34. Fuel Control

#### 01.5.34 Fuel Control

A fuel control may be carried out at any time during a meeting, according to the FIM Motocross World Championships Regulations.

All requests for fuel controls following a protest must be accompanied by a deposit of US\$ 1'000.— ( $\in$  800.—) paid to the competent body or the FIM (supplementary controls).

Any new requests for controls must be presented to the FIM within 5 days of the reception date of the results of the preceding control notified in conformity with the FIM Motocross World Championships Regulations.

#### After the last control:

- The winning party will have its deposit reimbursed;
- The losing party will have to pay the costs of all the controls carried out after deduction of deposits which it had already paid.

A rider whose fuel fails to meet the technical requirements will be disqualified from the whole meeting and forfeit all Championship points and trophies earned. This rider will also be liable for the reimbursement of the full costs of the test. Further penalties may be imposed.





Protests must be lodged according to the FIM Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of US\$ 800.− (€ 640.−) or the equivalent amount in local currency, returnable if the protest is justified.

Generally, protests against the eligibility of a rider, entrant or a motorcycle entered, must be made before the start of the official practice.

An appeal may be made against a decision of the International Jury to the International Disciplinary Court (CDI).

Protests entailing a fuel control must be accompanied by an additional deposit of US\$ 1'000.– ( $\in$  800.–).
