

Anti-Doping Education & Learning (ADEL)

UPDATE TO REQUIREMENT FOR COMPLETION OF WADA ON-LINE ANTI-DOPING EDUCATION & LEARNING PROGRAM

Dear FMN & CONU Colleagues,

We refer to our previous bulletins of 21st May & 20 October 2019 regarding the above in which we informed you that all applicants for a FIM rider's license from 1st November 2019 are required to provide evidence of their use of anti-doping educational material from a number of sources to confirm their understanding of their roles and responsibilities in relation to anti-doping.

This remains a requirement and, as before, can be achieved in a number of ways:

• Completion of the ADEL program which is the preferred option and provision of the certificate of completion to the FMN issuing their license.

When it is not possible for the ADEL program to be used, for example, for reasons of language or where the FMN is already using an alternative program, the following options are still acceptable:

• Completion of similar on-line education and e-learning programs available to Federations at a national level from National Anti-doping Organisations (NADOs) in the relevant languages. We are aware that many FMNs have access to such programs and some are already using them for this purpose.

INFORMATION REGARDING THE NEW 2021 ADEL PLATFORM

As a new WADA Code has been introduced from 1 January 2021 including the introduction of a new WADA International Standard for Education as part of the 2021 World Anti-Doping Code, the programs on the ADEL platform have been updated to comply with the new Code.

The ALPHA program no longer exists and has been replaced by the International-Level Athlete Education Program which should be completed by riders competing in FIM World Championships & Prize events and in CONUs Championships.

There is also now a **National-Level Athlete Education Program** for riders competing at national level.

Many Federations have already successfully implemented the program with riders completing it as part of the license application process and have provided us with valuable feedback.

The most suitable option remains at the discretion of each FMN.

RIDER CONSENT FORM

Completion of the existing Rider Consent Form remains compulsory. However, as required by WADA, this is no longer included within the FIM Anti-Doping Code.

This would be particularly relevant for riders applying for a single event license as at present and those who have the opportunity to compete in an FIM event at short notice and those for whom the previous options are not available.

The National Federation that issues the riders' license should continue to ensure that they receive confirmation of participation in the ADEL or other national anti-doping education & learning program or that the existing Rider Consent Form is signed as at present.
