

## GENERAL RULES OF THE FIM TROPHIES

### Article 1. Purpose of the FIM Trophies

The FIM Trophies recognise and celebrate individuals or corporate entities who have significantly contributed to the development and promotion of the beyond-sport activities related to different motorcycling fields.

### Article 2. Who can take part in the FIM Trophies?

Any FMN, FIM body, or other person involved in motorcycling activities may submit a candidature. Any Trophy may be awarded to individuals or legal entity, including FMNs.

#### **Conditions:**

- FIM staff, members of the Awards and Recognition Committee, members of the FIM Trophy Jury, the FIM bodies are not eligible to apply.
- Previous winners of any Trophy are not permitted to submit the same application for any other Trophy category. In addition, winners cannot apply for the same Trophy category within a three-year period.
- Each candidate may submit only one project at a time and may apply for only one Trophy.
- Candidates may only submit the same application twice.
- The submitted application can only be for a project completed within the last three years or currently in progress.
- Access to the FIM Trophies is free of charge.

### Article 3: The application file and its submission

Candidates must compile a file comprising:

- a) the [online application form](#) in English
- b) a 30-second video to be sent by email: [recognition@fim.ch](mailto:recognition@fim.ch)

The deadline for receipt of applications is midnight on June 30. Applications received after this date and time will not be accepted.

Any application that is incomplete or contains false information will be considered null and void.



#### **Article 4. Calendar (Trophy year)**

1. Call for applications on 1 March
2. Submission of applications: < 30 June
3. Jury's selection / Approval by the Board of Directors: on the next scheduled Board of Directors
4. Information to candidates: following the Board of Directors approval
5. Presentation of Awards: During the annual FIM Awards ceremony.

#### **Article 5. Composition of the Jury for each Trophy**

##### **Each Jury is composed as follows:**

- **The President of the Jury** appointed by the Awards and Recognition Committee from among its members
- **Two members** of the Awards and Recognition Committee chosen by the Awards and Recognition Committee from among its members
- **Two experts** appointed according to the specific rules of each FIM Trophy

The Jury members evaluate and study the received applications. During deliberations, the Jury selects the nominated applications and the winners based on the selection criteria.

Each member of the Jury has one vote, except in the event of a tie where the vote of the President of the Jury has an additional vote.

The Jury is independent. The Jury's decision is discretionary and is presented to the Board of Directors for approval.

Any Jury member who has a conflict of interest with a candidate must disclose it and abstain from participating in the Jury's deliberations.

The Jury members who have access to the files submitted as part of this competition commit to keeping all information regarding the file and the candidate confidential.

The FIM reserves the right not to award any prize if no application complies with these requirements.

#### **Article 6: Selection of nominees and winners**

The winners will be announced and rewarded during the FIM Trophies ceremony at the FIM Awards. The FIM will cover travel and accommodation expenses for a maximum of one participant.

The winners will receive a Trophy.

The winners and nominees of the various prizes authorise the FIM and its partners to use their name and image in the context of the promotion of the FIM Trophies and subsequent editions in all kinds of printed and digital documents, including but not limited to press reviews, photos, videos, interviews, and recordings to the exclusion of any communication for commercial or promotional purposes.

The winners have the right to use the "FIM Trophy Winner" logo of the corresponding year.



## SPECIFIC RULES FOR THE FIM TROPHIES:



### FIM SUSTAINABILITY TROPHY

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Sustainability Trophy. Through this Trophy, the FIM encourages a greater awareness of **environmental concerns and wants to reward a significant contribution to responsible practices and sustainable activities in the world of motorcycling.**

#### **The experts of the Jury:**

- FIM CID Director
- An expert appointed by the Chairman of the Awards and Recognition Committee

#### **Selection criteria:**

The Jury will choose the winner of the Trophy based on predefined and objective criteria listed below:

1. **Environmental innovation:** Recognition of innovative initiatives aimed at minimising environmental impacts, such as the use of green technologies, the implementation of energy-efficient solutions, or the introduction of sustainable practices.
2. **Emissions Reduction:** A measure of efforts to reduce carbon emissions, whether through cleaner technologies, sustainable transport practices, or initiatives to offset emissions.
3. **Biodiversity Conservation:** Recognition of actions to preserve and restore biodiversity, whether through tree planting initiatives, protection of local flora and fauna, or other conservation-related projects at competition venues.
4. **Education and awareness:** Evaluation of educational programmes and awareness-raising efforts to inform and mobilise the community on environmental issues related to motorcycling sports.
5. **Leadership in sustainability:** Recognition of the leadership role the individual or organisation plays in promoting sustainability within motorcycling.



## **FIM FAIR PLAY TROPHY**

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Fair Play Trophy. Through this Trophy, the FIM wishes to raise awareness about the concept of Fair Play and reward a significant act of fair play in motorcycling sport.

### **The experts of the Jury:**

- FIM Sport Director
- An expert appointed by the Chairman of the Awards and Recognition Committee

### **Selection criteria:**

The Jury will choose the winner of the Trophy based on predefined and objective criteria listed below:

- 1. Exemplary sportsmanship:** It is essential to assess the candidate's general attitude, highlighting his or her sportsmanship and exemplary conduct both on and off the pitch. It includes how the candidate interacts with competitors, officials, and fans.
- 2. Respect for rules and opponents:** Recognition of the respect shown towards the rules of motorcycling sport and opponents is fundamental to promoting fair and ethical competition.
- 3. Positive contribution to the image of motorcycle sport:** Actions that contribute positively to the image of motorcycle sport, both locally and globally, are crucial. This point may include social responsibility initiatives, ride clean, charitable commitments, or actions that benefit the motorcycling community.
- 4. Heroic or inspirational actions:** Highlighting exceptional actions, whether heroic, inspirational or embodying the very spirit of fair play in particular circumstances, is an important indicator for recognising exemplary and motivating behaviour.
- 5. Positive impact on the community:** The evaluation of the applicant's actions' positive impact on the motorcycling community, whether at the local, national, or international level, allows to scope the extent of these actions and their contribution to fostering a positive sporting environment.



## **FIM ROAD SAFETY AND PUBLIC AFFAIRS TROPHY**

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Road Safety and Public Policy Trophy. Through this Trophy, the FIM gives more visibility to road safety and public policy matters.

### **The experts of the Jury:**

- FIM CPM Director
- An expert appointed by the Chairman of the Awards and Recognition Committee

### **Selection criteria:**

The Jury will select the Trophy winner based on predefined and objective criteria listed below:

- 1. Road safety initiatives:** Evaluation of the specific initiatives implemented by the candidate to promote road safety, including educational programmes, awareness campaigns, or efforts to enhance road infrastructure.
- 2. Innovation in motorcycle safety:** Valuation of innovative efforts aimed at increasing motorcyclist safety, whether through the introduction of new technologies, the development of safety equipment, or the implementation of specific measures on the roads.
- 3. Commitment to public affairs:** Recognition of the candidate's involvement in public affairs issues related to motorcycling, such as participation in government consultations, collaboration with road safety organisations, or defence of motorcyclists' rights.
- 4. Collaboration with stakeholders:** Assessment of the applicant's collaboration with stakeholders, including governments, road safety organisations, non-governmental organisations (NGOs), and others in the field, to improve road safety.
- 5. Positive impact on public perception:** An assessment of the positive impact of the applicant's actions on the public perception of motorcycling as a safe and responsible means of transport, thereby contributing to a positive public image of the sector.



## **FIM TROPHY FOR THE FUTURE**

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Trophy For The Future. The FIM wishes to recognise and celebrate those who significantly contribute to improving the presence of the youngsters in all motorcycling-related areas and developing the future of the sport.

### **The experts of the Jury:**

- FIM Marketing Director
- An expert appointed by the Chairman of the Awards and Recognition Committee

### **Selection criteria:**

The Jury will choose the winner of the Trophy based on predefined and objective criteria listed below:

- 1. Development of youth programmes:** Recognition of concrete initiatives aimed at developing specific programmes and competitions for young people in motorcycling, such as academies, training camps or mentoring.
- 2. Attraction of young volunteers and involvement in other functions:** Assessment of the applicant's ability to attract young volunteers and involve them in other motorcycling-related tasks according to their skills and interests.
- 3. Future of the sport:** Assessment of the applicant's actions to anticipate the development of motorcycling in the future, including the development of innovative strategies and initiatives to ensure the sustainability and continued growth of the sport.



## **FIM WOMEN'S TROPHY**

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual FIM Women Trophy. With its Women in Motorcycling Trophy, the FIM wishes to recognise and acknowledge those who have significantly contributed to improving and developing the presence of women in all motorcycling-related areas and encouraged greater awareness of women in motorcycling.

### **The experts of the Jury:**

- FIM CFM Director
- An expert appointed by the Chairman of the Awards and Recognition Committee

### **Selection criteria:**

The Jury will choose the winner of the Trophy based on predefined and objective criteria listed below:

- 1. Contributions to the improvement and development of women's participation:** Assessment of the candidate's significant contributions to the improvement and development of women's participation in all areas of motorcycling, including competition, events, administrative roles, and advocacy.
- 2. Encouraging awareness of women in motorcycling:** Recognition of the applicant's efforts to encourage greater awareness of women in motorcycling, including through awareness campaigns, educational and sporting initiatives or inclusive partnerships, and advocacy.
- 3. Promotion of equal opportunities:** Assessment of the applicant's promotion of equal opportunities, ensuring that women have fair opportunities to participate at all levels of motorcycling.



## **FIM FAMILY TROPHY**

In order to encourage the FMNs to create and promote particularly relevant and innovative projects for the development of motorcycling activities, the FIM has created the FIM Family Trophy. Projects submitted by FMNs will be assessed by the CMRF Committee and a selection of projects which are not in the scope of other trophies will be presented to the FIM Awards and Recognition Committee to award the FIM Family Trophy to the FMN with the most deserving project. While projects may cover both sporting and non-sporting areas, they must be of particular relevance for the development of motorcycling activities by the applicant federation. If no project among the CMRF is selected, the Awards and Recognition Committee reserves the right to award an FMN for an extraordinary act of humanitarian aid carried out in the past year.

### **Selection criteria:**

The Jury will select the Trophy winner based on predefined and objective criteria listed below:

- 1. Innovation:** The project must present innovative and original ideas for developing motorcycling activities within the candidate Federation. It must demonstrate a creative and inventive approach in its conception and implementation.
- 2. Impact:** The project must significantly impact the motorcycling community, locally or globally. It should make a tangible contribution to improving or promoting motorcycling activities by fostering growth, safety, inclusion, or other vital aspects of the sport or solidarity.
- 3. Relevance to the development of motorcycling activities:** The project must be directly related to the development and promotion of motorcycling activities. It should respond to the specific needs and challenges the motorcycling community faces, offering effective solutions tailored to its needs.
