

FIM ENVIRONMENT TROPHY GENERAL INFORMATION



The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Environment Trophy. Through this Trophy, the FIM encourages a greater awareness of environmental concerns and wants to reward a significant contribution to environmental protection.

1. ELIGIBILITY

This Trophy is awarded to either an individual, a legal entity or a FIM Body that have made a significant contribution or done something important to **enhance environmental awareness in the field of motorcycling.**

- FIM Staff and International Sustainability Commission (CID) Members are not eligible.
- Prior to submitting the candidature, the applicant must inform the relevant FMN.
- Candidates are not permitted to submit the same candidature more than twice.
- Candidatures must be presented in English or French only.
- Candidatures can be related to sporting or non-sporting activities.
- Candidatures may be submitted by:
 - o an FMN
 - o a FIM body
 - $\circ \quad \text{the applicant} \quad$
 - any other person involved in the application
- There is no restriction as regards the period considered to award the Trophy. For example, a project made in 2020 can be awarded in 2023.

2. SCOPE OF THE TROPHY

Examples of programmes, initiatives, projects, activities, events, campaigns that may be eligible:

- **Climate action:** generation or development of alternative energy, clean energy promotion, greenhouse gas emissions mitigation
- **Sustainable event management:** food wasting / pollution prevention / recycling / green purchasing/water saving
- Environmental education
- Biodiversity protection
- Eco-fuel implementation
- Decarbonisation carbon compensation initiatives



3. JURY

All candidatures will be examined by an independent Jury composed by five members as follows:

- One Member of the FIM Awards and Recognition Committee designated by the Chairman of • the Committee
- The Director of the FIM International Sustainability Commission (CID)
- Three experts designated by the two other members above mentioned and approved by the BD. Nomination can be renewed every year.

The Jury will select the Trophy Winner based on predefined and objective criteria listed in the evaluation sheet such as

- Reduction of the impact/benefits on the environment
- **Concrete actions towards environmental awareness**
- Concrete actions towards preserving nature in relation to motorcycling activities
- Behavioral change in the long run towards improving motorcycling activities impact on the environment
- Concrete actions through motorcycle sport to create innovative and positive impact on the environment

4. TROPHY PRESENTATION

The winner will be invited on stage during the annual FIM Awards Prize Giving Ceremony. The travel and accommodations expenses are borne by the FIM for one participant maximum.

The FIM Administration reserves the right not to award the prize, should no candidature be in accordance with the present requirements.

FIM FAIR PLAY TROPHY GENERAL INFORMATION

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Fair Play Trophy. Through this Trophy, the FIM wishes to raise awareness about **the concept of Fair Play and reward a significant act of fair play in motorcycling sport.**

1. ELIGIBILITY

This Trophy is awarded to either an individual, a legal entity or a FIM Body that have made a significant contribution or have shown an attitude that manifests **the spirit of fair play in the field of motorcycling.**

- FIM Staff are not eligible.
- Prior to submitting the candidature, the applicant must inform the relevant FMN
- In case of rejection of the candidature by the FMN, the candidate can revert to the Committee for further explanation.
- Candidates are not permitted to submit the same candidature more than twice.
- Candidatures must be presented in English or French only.
- Candidatures can be related to sporting or non-sporting activities.
- Candidatures may be submitted by:
 - o an FMN
 - o a FIM body
 - $\circ \quad \text{the applicant} \quad$
 - any other person involved in the application
- There is no restriction as regards the period considered to award the Trophy. For example, a project made in 2020 can be awarded in 2023.

2. <u>SCOPE OF THE TROPHY</u>

Examples of fair play acts, attitudes, activities, initiatives, programmes, events, campaigns that may be eligible, including but not limited to:

- Team spirit: Sharing the moment of victory with a team
- Ride Clean: Fair play means not cheating by taking drugs or doping
- Integrity: Practicing sport within a sound ethical framework
- Solidarity, Friendship & Care: Mutual support, rivalry on the field does not exclude friendship
- **<u>Respect</u>**: Self control by accepting sensitive behaviors or decisions. Respect the officials and their decisions



All candidatures will be examined by an **independent Jury** composed by five members as follows:

- One Member of the FIM Awards and Recognition Committee designated by the Chairman of the Committee
- The FIM Sports Director
- Three experts designated by the two other members above mentioned and approved by the BD. Nomination can be renewed every year

The Jury will select the Trophy Winner based on predefined and objective criteria listed in the evaluation sheet such as

- The candidate has promoted clean sport
- The candidate has shown respect of the rules
- The candidate has shown respect towards the opponents and self-control at all times
- The candidate has shown respect towards the officials and other persons involved in the organisation
- The candidate helps to inspire fair play and good behavior in the field of play (e.g modesty, friendship)

4. TROPHY PRESENTATION

The winner will be invited on stage during the annual FIM Awards Prize Giving Ceremony. The travel and accommodations expenses are borne by the FIM for one participant maximum.

FIM ROAD SAFETY AND PUBLIC POLICY TROPHY



GENERAL INFORMATION

The Fédération Internationale de Motocyclisme (FIM) is pleased to call for candidatures for its annual Road Safety and Public Policy Trophy. Through this Trophy, the FIM gives **more visibility to road safety and public policy matters.**

1. ELIGIBILITY

This Trophy is awarded to either an individual, a legal entity or a FIM body that **have performed in an outstanding way in one of these above-mentioned areas.**

- FIM Staff and Commission for Mobility (CPM) Members are not eligible.
- Prior to submitting the candidature, the applicant must inform the relevant FMN.
- Candidates are not permitted to submit the same candidature more than twice.
- Candidatures must be presented in English or French only.
- Candidatures can be related to sporting or non-sporting activities.
- Candidatures may be submitted by:
 - o an FMN
 - $\circ \quad \text{a FIM body} \quad$
 - $\circ \quad \text{the applicant} \quad$
 - $\circ \quad$ any other person involved in the application
- There is no restriction as regards the period considered to award the Trophy. For example, a project made in 2020 can be awarded in 2023.

2. SCOPE OF THE TROPHY

Examples of programmes, activities, initiatives, projects, events, campaigns that may be eligible:

- Training for decreasing the number of road traffic accidents
- Equipment that help reducing the number of deaths and severity of injuries
- Accidentology research
- Continued education, post-licence motorcycling training
- Better legislative framework for motorcycling activities worldwide



All candidatures will be examined by an **independent Jury** composed by five members as follows:

- One Member of the FIM Awards and Recognition Committee designated by the Chairman of the Committee
- The Director of the Commission for Mobility (CPM)
- Three experts designated by the two other members above mentioned and approved by the BD. Nomination can be renewed every year

The Jury will decide the Trophy Winner based on predefined and objective criteria listed in the evaluation sheet such as:

- **Innovation and creativity:** The recipient should have demonstrated a unique and innovative approach to road safety and public affairs, such as developing new technologies or processes to improve road safety, or implementing creative public affairs campaigns that engage the community and raise awareness of road safety issues.
- **Impact and effectiveness:** The recipient should have achieved significant impact and effectiveness in improving road safety and raising public awareness of road safety issues, such as reducing traffic accidents or fatalities, increasing public support for road safety initiatives, or influencing policy changes that improve road safety. The recipient should create a lasting legacy in the field of road safety and public affairs.
- **Collaboration and partnership:** The recipient should have demonstrated effective collaboration and partnership with other organisations or stakeholders, such as government agencies, non-profit organizations, businesses, or community groups, to advance road safety and public affairs goals.
- Advocacy and education: The recipient should have shown a commitment to advocacy and education on road safety issues, such as promoting safe driving practices, advocating for policy changes to improve road safety, or developing educational programmes that promote safe driving habits.

The winner will be invited on stage during the annual FIM Awards Prize Giving Ceremony. The travel and accommodations expenses are borne by the FIM for one participant maximum.

1. ELIGIBILITY

This Trophy is awarded to either an individual, a legal entity or a FIM Body that have made a significant contribution to encourage the youngsters in all motorcycling activities and/or that foresee the development of the sport for the future.

- FIM Staff are not eligible.
- Prior to submitting the candidature, the applicant must inform the relevant FMN.
- Candidates are not permitted to submit the same candidature more than twice.
- Candidatures must be presented in English or French only.
- Candidatures can be related to sporting or non-sporting activities.
- Candidatures may be submitted by:
 - o an FMN
 - o a FIM Body
 - o the applicant
 - o any other person involved in the application
- There is no restriction as regards the period considered to award the Trophy. For example, a project made in 2020 can be awarded in 2023.

2. SCOPE OF THE TROPHY

Examples of programmes, initiatives, events, activities, projects or campaigns that may be eligible:

- Covering youngsters' activities and achievements in the media in an effective manner
- Providing competitive opportunities for youngsters at national, continental or international level
- Promoting youngster's role models and developing mentoring programmes

- Engaging university students in motorcycling sport or sport in general relevant for motorcycling

- Anticipate the development of the motorcycling sport to attract the new generation: e-sport, web3, metaverse, smart stadiums with hologram displays, video walls, social media follower-based seating, virtual reality and artificial intelligence applications

- The FIM Marketing Director
- Three experts designated by the two other members above mentioned and approved by the BD. Nomination can be renewed every year

The Jury will select the Trophy Winner based on predefined and objective criteria listed in the evaluation sheet such as:

- Raise awareness in all motorcycling activities among youngsters
- Increase the participation of youngsters in competition/create new competition
- Attract young volunteers and other functions relative to their capacity
- Train young riders in relation to safety matters
- Foresee the development of the sport for the future

- FIM Staff and Women in Motorcycling Commission (CFM) are not eligible.
- Prior to submitting the candidature, the applicant must inform the relevant FMN
- In case of rejection of the candidature by the FMN, the candidate can revert to the Committee for further explanation.
- Candidates are not permitted to submit the same candidature more than twice.
- Candidatures must be presented in English or French only.
- Candidatures can be related to sporting or non-sporting activities.
- Candidatures may be submitted by:
 - o an FMN
 - o a FIM body
 - \circ the applicant
 - any other person involved in the application
- There is no restriction as regards the period considered to award the Trophy. For example, a project made in 2020 can be awarded in 2023.
