







## **1. ANNOUNCEMENT**

The **TT Circuit Assen**, on behalf of **KNMV**, **Santander Salts Ltd, Championship promoter** and the **Fédération Internationale de Motocyclisme**, organises a race of the FIM Sidecar World Championship.

This event will take place from the  $23^{rd}$  till  $25^{th}$  July 2021 on the TT Circuit Assen. IMN n°: 105/02

## 2. ORGANISATION

## 3. CIRCUIT

TT Circuit Assen length is 4.542 km, the race will be run clockwise (see map enclosed).

## ACCES TO THE CIRCUIT

The access to the Circuit will be authorised from **Wednesday 21st: 10:00**. See document 2021\_NED\_Team\_Event\_Guide enclosed.

Each participant will need to print the correct pass and show in the windscreen of each vehicle that attends the meeting.

Trucks will be parked within the WSB Paddock – see plan enclosed.

**Cars** will be parked **outside of the main paddock** and people walk to their Team's set-up within the enclosed WSB Paddock Area.

The Registration made for you all on the participant platform (including all your nominated support crew) has generated an App registration email to each person.









## **SBK Pit In mobile Application**

Download the SBK Pit In App from Google Play Store or App Store.

As long as a person is entered on the the WSB system and they have their invitation letters with them - they will be able to access the paddock and go to the Checking Area where they will be assisted to get the App onto their phones, or they will be signed in manually.

You will be asked to sign the relevant documents at Paddock Check-In and present your negative Covid-19 Test certificate. Test must be carried out a maximum of 72 hours prior to your first time Paddock entry.

The positioning of the competitors in the paddock will be subject to prior authorisation from the organization (see map enclosed).

It is forbidden to the competitors and users of the Working Paddock and the Support Paddock to fit any metal objects in our asphalt surfaces such as tent pegs, nails...

In the event of a disrespect of these rules, the competitors may be penalised and/or fined.

## 5. ENTRIES & DEPOSIT

Applications for entry shall be made on the official forms included with these regulations.

Applications shall be approved by the rider' & passenger's FMNs and shall reach the **organisers** no later than 30 days previous the start of the event.

## Entry fees: 500EUR.

## **Deadline:** 30 days previous the start of the event.

The Promoter will select the applications and advise teams within 72 hours after the closing date of entries whether their applications have been accepted for the event.

## PASSES/ACCREDITATION

One event credentials are provided by DWO as follows:

- Worker wristbands 6 per team (including driver/passenger)
- Team associate pass 4 per team
- One working vehicle hanger
- One living vehicle hanger

Please note there is no access to the secure WorldSBK paddock under the Dorna/WSBK Covid operational protocol.

Passes will be allocated on arrival by DWO.

All the other persons (officials/staff/ promoters and journalists) holders of pit lane access must personally collect their accreditation at the Paddock Check in upon presentation of an ID or passport.

## TIME KEEPING:

The cost of the transponder rental is  $70 \in$  (vat included) if you <u>don't</u> have your own transponder.

In case of loss or damage, the price is 400€ (vat included).

The transponder delivery is in our time keeping room (control tower).

Thursday 22/07/2021 from 15.00 until 18.00

The transponder <u>must</u> be returned asap after Sunday Race 2.

## 9. PRIZE-GIVING

At the victory podium, after both races.

Trophies will be provided by the **Championship promotor**, 2 trophies per teams: one for each, rider & passenger for each race.

## 10. PROTESTS

All protests shall be made in accordance with the requirements of the FIM Disciplinary and Arbitration Code and be accompanied by a fee of  $660,00 \in$ .

## 11. FUEL

If fuel is not supplied by the organisers. The used fuel must be in conformity with Article 2.10 of the Road Racing Sidecar World Championship Regulations.

## **12. THIRD PARTY INSURANCE**

By endorsing the application form for entry the FMN of the rider certifies that the rider is insured in accordance with the FIM requirements.

In conformity with Article 110.1 of the Sporting Code, third party insurance in respect of riders covering accidents occurring during the meeting including practices will be the responsibility of the organiser.

This insurance includes a guarantee of **EUR 120.000,00**.

The organiser disclaims all responsibility for damage to a machine, its accessories and components arising out of an accident, fire or other cases.

## **13. RENUNCIATION OF ANY RECOURSE AGAINST SPORTING AUTHORITIES**

Apart from the requirements of the FIM Sporting Code, riders and teams by participating renounce all rights of appeal against the organiser, his representatives or







agents by arbitration or before a tribunal or any other manner not foreseen by the FIM Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of the organiser, his officials, representatives or agents in the application of these regulations or contributed to or arising out of their actions.

## 14. RIDER'S EQUIPMENT

According to article 3.4 of the FIM Statutes & By-Laws, the FIM is the sole owner of all television rights for the World Championships.

An on-board camera (other than the one from the FIM Championship Promoter or permitted by the FIM Administration) is not allowed during the entire event, from the practice sessions until the end of the event. If riders wish to place their own on-board camera, they must contact the Championship Promoter, for approval at: **mikedommett@hotmail.com** 

(see appendix - Onboard camera installation guide)

The FIM reserves the right to ask the riders for images from their on-board cameras.

## 15. ENVIRONMENTAL MAT

As per article 4.1 of the FIM Environmental Code of 2018 regarding the protection of the floor, Superside teams must accomplish the usage of an standardized environmental mat.

The Environmental Mat must be composed of an absorbent upper part and an impermeable lower part. The use of an environmental mat protecting the ground (or other effective system for events taking place at circuits with permanent facilities) to prevent soil and water contamination is compulsory:

- a) Wherever work on motorcycles is allowed by the organisers;
- b) Under all waste oil and fuel containers provided by the organisers;
- c) At all official refuelling points;
- d) Under all thermic powered generators and power washers. FIM Sidecar World Championship page 7 / 7 The minimum technical data for the mat are:
- Dimensions: Minimum 160 cm X 100 cm

Any infraction of this rule will be reported to the International Jury who will fine the rider responsible a maximum of EUR 370.- or any other amount mentioned in the regulation or appendix of the discipline. Other sanctions can be pronounced by the International Jury in accordance with the competences mentioned in Article 3.1.3 of the Disciplinary and Arbitration Code (DAC) and Article 50.1.3 of the Sporting Code.

## 16. HEALTH PROTOCOL (2021)

A sanitary protocol is force with regards to the Covid-19 sanitary crisis in all FIM World Championship events.









- Wear a protective mask properly in the paddock
- Wash your hands frequently with soap
- Use hydroalcoholic gel
- Avoid touching your eyes, mouth or nose.
- Avoid crowded places
- When possible maintain a safe distance of 2 meters
- Clean the items you have used, or you are going to share
- Avoid handshakes, hugs and sharing bottles and glasses with others
- If you have symptoms contact immediately the Medical Centre DO NOT ATTEMPT TO ENTER THE MEDCIAL CENTRE

All persons participating in the event and entering the circuit must comply **with the WorldSBK Contingency Plan for SARS-CoV-2 - v1.2 - 10Jun2021 (see enclosed)** 

Any breach by a person belonging to a competitor's organization may be the subject of a report from the organizer to the sports authorities in addition to possible legal proceedings.



#### WorldSBK PADDOCK: Event Scenario 2 with UP-DATED PADDOCK ENTRY RULES.

#### WorldSBK STAFF

All participants with WorldSBK Paddock Access will have to present as Covid Certificate one of the two following documents:

**Option 1:** certificate of a negative Covid-19 Test carried out a maximum of 72 hours prior to entering the Paddock for the first time. Accepted certificates include negative PCR or negative Antigen Test.

Option 2: certificate with fully completed vaccination.

Electronic control access for WorldSBK Paddock will start on Tuesday at 9:30 h and will last until Sunday 17:00 h.

#### **REGISTERED CREDENTIALLED GUESTS**

Registered credentialled guests will be granted with access to WorldSBK Paddock on Saturday and Sunday only. Passes are valid for both days (no single day passes). All registered credentialled guests with WorldSBK Paddock Access will carry out a mandatory Antigen Test at the Eurofins Laboratory situated at the Circuit, close to the Medical Centre. Test will be required on the day of the first time paddock entry. Antigen Test results will be available in approximately 30 minutes. Maximum number of registered credentialled guests will be communicated to all Teams' Managers.

#### **Eurofins Laboratory - NO BOOKINGS NEEDED**

Eurofins will run Antigen & PCR testing for country departure as well as Antigen testing for Paddock Entry. All PCR Tests carried out before 15:00 h  $\rightarrow$  results on the following day before 15:00 h. All PCR Tests carried out after 15:00 h  $\rightarrow$  results in 36 hours. Antigen Test results will be available in approximately 30 minutes. All results will be sent by e-mail. Note that in Assen the TrustOne App WILL NOT BE OPERATIVE. Be aware, that the Dutch Government up-date the list of areas frequently and classifies entry rules per areas, not per countries - you must check the exact area from where you will be travelling. #### **INTRODUCTION**

This document is intended to provide a guide for the installation and use of On Board cameras in Sidecar competitions.

It describes the proper way to install these cameras so as to guarantee the maximum safety for the drivers and the passengers while obtaining as far as possible the most spectacular shots.

#### **IMPORTANT NOTICES**

One On Board camera is composed of Two (2) parts: the support (bracket) and the camera.

The support shall be installed by a representative of the sidecar team (e.g. the rider) **and checked y a technical official during the pre event technical controls** The latter's role shall be limited **to verify that the installation has een ade according to this guide**.

The sidecar team member **is at all ti e** solely responsible for the installation of the support.

The On Board cameras shall be installed when the fairing is assembled on the chassis. Sometimes, depending on the sidecar camera position, it may be necessary to install the support before the fairing has been assembled and then assemble the fairing.

To attach the support, a small hole must be drilled in the sidecar fairing for the support of the On Board camera to be attached as shown. Washers shall be used to adjust and fix the support units.

Holes may be drilled only with the express agreement of the sidecar team and using their own tools and bores.

The support of the On Board camera shall be placed over the hole using the proper screws. It shall then remain affixed to the sidecar after the race in order to be used in the next race**s events**.

The assembly shall be duly checked before each race in the presence of one sidecar team member.

Once the support of the On Board camera unit has been affixed to the fairing, the tea

e er responsi le e g the rider shall install the On Board camera before the start of the race in order to obtain the right frame.

Each sidecar team will at all times be fully responsible for ensuring that any on board camera is correctly installed in accordance with this installation guide.

The cameras **ay** be switched on during the Starting Grid.

A proper first installation of one (1) On Board camera unit requires approximately 45 minutes.

The support shall be installed during or the day prior to the qualifying sessions and before the sidecars enter the Parc Fermé.

Once installed, the support **s** will remain affixed to the sidecars. However, it will still be necessary to check the supports before each day of racing **y the event officials**





## COVID-19 TESTING AT WorldSBK EVENTS

17<sup>th</sup> May 2021

As you maybe already aware Dorna WSBK Organization has reached an agreement with **Eurofins Laboratory**. Eurofins will set up a mobile laboratory at all Circuits and will provide certified Antigen and PCR Tests.

### Tests Process Time - PADDOCK ENTRY

- Antigen test results will be available in approximately 20-30 minutes.
- Tested person should wait at the temporary parking that will be set up at all Circuits in close distance from the Eurofins Area.
- Once results are delivered, negative person can proceed to Paddock Check In.
- In case of any positive result, relevant Covid-19 suspicious protocol will be activated as per applicable law in each country.

### **Tests Process Time - DEPARTURE**

- Antigen tests results will be available in approximately 20-30 minutes.
- PCR tests results will be available as per test extraction time:
  - All tests with extraction before 15:00 h. -> results within 24 hours.
  - All tests with extraction after 15:00 h. -> results within 36 hours.

### Eurofins Laboratory opening times for PIRELI ARAGON ROUND

- The survey carried out in the previous weeks shown that most of the essential staff will bring their Covid-19 certificate to enter the Paddock with them.
- Expecting a reduced number of Antigen tests from Tuesday to Friday; the opening hours were adjusted:
  - Tuesday, 18th May: 09:00 18:00 h
  - Wednesday, 19th May: 09:00 20:00 h.
  - Thursday, 20th May: 09:00 18:00 h.
  - Friday, 21st May: 09:00 18:00 h.
  - Saturday, 22nd May: 08:00 18:00 h.
  - Sunday, 23rd May: 08:00 14:00 h.

We would like to ask you for your collaboration encouraging your staff to proceed with departure testing during the whole day and not to wait for the last minute. We are aware that specially on Saturday afternoon we may need to extend the opening hours after 18:00 h and we will make sure that all persons who will book a test will be attended. Opening hours for next rounds will be confirmed shortly as per our experience in MotorLand Aragón.



## 1. INTRODUCTION

According to the opinion of epidemiologists and public health specialists, the measures the Government takes when it comes to returning to the workplace depends on how the pandemic progresses and on the discovery of how many people have really suffered from the disease, so as to know the degree of immunisation in society.

The Situation around world in general is changing quickly as the scientists keep developing new vaccines to minimize the Covid-19 impact on society. There are continuous signs suggesting that the measures to enable a return to normality will be applied step by step.

The **MOTUL FIM Superbike World Championship presents** a **Contingency Plan for SARS-CoV-2** (hereinafter referred to as the "Contingency Plan") that allows the championship to take place under different scenarios expected to be developed throughout the season.

The WorldSBK Contingency Plan is a dynamic document based on continuous consultancies and supervision by Medical, Covid-19 Prevention and Event Contingency Experts as well as close collaboration with Event Organizers. More and more activities will be allowed, and there will be strict scrutiny to see if there are any new outbreaks, with the possibility of reversing some of the measures.

### Purpose of the Plan

The purpose of this document is to provide relevant information for the manufacturers, participating teams and all companies of the Championship, with regards to the procedures required for the organization of WorldSBK Events under the current situation of the Covid-19 global pandemic.

This Plan is related to the development of the different medical prevention measures and Health & Safety protocols which were approved by the relevant authorities of the country.

This Plan is a dynamic document and is valid for all Events starting from the Aragon Round (MotorLand Aragón, 21<sup>st</sup> - 23<sup>rd</sup> May 2021) and is being adapted from time to time and possibly from event to event, taking into account the local and any other applicative legislations in each country.

The Medical Commission of the Championship, composed by FIM and Dorna members, together with the expert prevention company have supervised and validated the Contingency Plan for SARS-CoV-2 to be applied during the entire event for all participants.

The Plan established by the organization of the WorldSBK Championship will exceed the minimum measures set out by the corresponding national government and will be compulsory for all participants. In the same way, any participating company/team shall create and follow their own protocols and procedures provided that they comply with the minimum measures outlined by FIM, MSMA and DORNA.



The Plan outlines the necessity for two essential figures:

- Medical Coordinator (Dr. Monica Lazzarotti, FIM WorldSBK Medical Director & Circuit Chief Medical Officer): Will be responsible for the management, reception of documents, screening and test results, liaison with the hospital and medical centre, etc.
- Covid-19 Contingency Operation managed by Mario Solana Abad (Verso Formación Emergencias y Seguridad SLU), Eva Jirsenska (Dorna WSBK Organization Srl Sucursal en España certified by the World Health Organization in Covid-19 Sports Mass Gatherings Risk Assessment) with support of Mauro Fiore (MF Ingegneria Srl) and Loredana Barsotti (Dorna WSBK Organization Srl) and Organization Department personnel of the Dorna WSBK Organization Srl: will be responsible for the fulfilment of the Contingency Plan, overseeing all H&S aspects and providing assistance to other teams/companies.

#### Plan compliance

The plan, as well as all the norms dictated by the Authorities in relation to the organization of sporting events, are obligatory for all the people who participate in the events of the Motul FIM World Superbike Championship, including, riders, team members, technicians, organization personnel, marshals, medical services or companions. Failure to comply with this protocol or any related norm will imply the application of a possible sanction.

Serious and/or relevant breach of this protocol or any related provisions may result in the expulsion of the accountable parties from the Events and/or from the Championships (including withdraw of the relevant Pass), without prejudice to any further remedies and/or actions DWO may have right to according to any applicable law.

#### Important

The message from the Medical Commission is for the paddock to have absolute control of all personnel movement once they have arrived at the event. It is recommended that the movement of the people participating in the event is limited to the circuit and hotel. Even if the region where the event is held is in a phase that allows restaurants and retail to be operative, the recommendation is to avoid interaction with other people as much as possible and therefore it is recommended that the paddock community follow a strict lockdown policy.

Special emphasis is given to all the Team Managers and Companies attending the event, who must assume the responsibility that each individual respect this rule.

Each Team/Company will appoint a person in charge of "Health & Safety" protocols.



# 2. SEASON STRATEGIC PLAN

The WorldSBK Championship, as well as our normal lives are marked by the Covid-19 prevention measures.

National Authorities frequently apply different grades of specific measures in different countries and regions. Mobility and travel restrictions represent additional barriers for the Championship organization.

Understanding that the situation in terms of organization of mass sports events can change with short notice, Dorna WSBK Organization (Dorna) has decided to implement different scenarios in events operation.

## Target

The Covid-19 pandemic outbreak brought to our current event management many new processes and sports events became ruled by Contingency Plans. Throughout the 2020 season new prevention measures were implemented and Championship activities involving guests and within the paddock were stopped.

Guests and spectators are a core part of the WorldSBK Championship and Dorna together with the Event Organizers will make their maximum effort to welcome them back.

Considering the importance of each and all stakeholders' profile, the 2021 WorldSBK Contingency Planning is based on the following **four general criterion and targets**:

- 1) Motorsport Events run with certain restrictions.
- 2) Limited capacity for general public.
- 3) Re-activation of hospitalities for team members and limited number of guests under specific Covid-19 prevention regulations.
- 4) Re-introduction of a limited public in Paddock Areas under specific Covid-19 prevention regulations.

#### **General Criterion**

All activities and use of relevant facilities during the race week will be based with a clear and absolute division into two zones:

#### Paddock Area

**Considered as "clean zone**" with strict control of all people accessing and moving within its boundaries.

#### **Circuit Public Areas**

considered as "unclean zone" with a different group of people and measures set directly by the National Authorities. Operation in these unclean zones will be fully under the management of the Event Organizers in accordance with the National/Regional rules/laws.



## **Covid-19 Transmission Mitigation**

To mitigate Covid-19 transmission at WorldSBK Events, access rules are being set for all participants with Paddock Access.

#### **Essential Staff**

- Entry to the paddock will only be permitted with a negative Covid-19 Test (PCR or Antigen) carried out independently of the country of origin, a maximum of 72 hours prior to Paddock Check In at the Circuit.
- > All participants must act responsibly, as recommended by the Medical Commission.
- Participants may choose the Testing Laboratory as per their preference and country of origin. Moreover, Dorna will provide all team/company managers with a list of partners' laboratories around the world to facilitate travel arrangements.
- For smooth operation, a Testing Facility will be set up at the Circuit entrance providing Antigen Test with results in approximately 20 minutes. This facility is set up for those participants who don't have any official test certificate valid at the time of their first-time Paddock entry.
- > This Testing Facility will also provide the service of PCR Testing with results in approximately 24 hours for those participants needing a PCR Test to return to their country of origin and/or further travel appointments.

#### **Guests & Spectators**

- To minimize Covid-19 transmission when allowing non-working participants (guests and/or spectators) to access the Paddock area, all guests and/or spectators who will be fully registered on the WorldSBK Digital Platform will be obliged to pass an Antigen Test at the Testing Facility at the Circuit Entrance. No other test will be accepted.
- > This testing will maximize the protection of the Paddock family.

The presence of different collectives (essential staff, guests & spectators) will be ruled by the Event Scenario – see following chapter for full details.

# Sporting Mass Risk Assessment for a WorldSBK Event as per World Health Organization

The World Health Organization (WHO) Risk Assessment licenced tool was used to evaluate overall transmission and further spread of Covid-19. All measures outlined in the Contingency Plan are in line with WHO recommendations.

Combination of all listed measures and rules ensures that **overall risk of transmission and further spread of Covid-19** at a **WorldSBK Event held within Europe** is considered **VERY LOW**.

This risk of transmission can only be stable as VERY LOW when all and each participant respect and follow all measures and rules outlined in this Contingency Plan.

The Decision Matrix together with Risk Evaluation and Risk Mitigation evaluation can be found in Annex 2.

For Overseas Events a specific risk assessment study will be carried out latest two months before the relevant event.



# **Public Attendance**

The attendance of public in the public areas (grandstands & general admission) - **unclean zone** - will be ruled by National Authorities.

The access of spectators to Paddock Areas will be studied together with Event Organizers and will be subject to approval by Dorna (see Event Scenario 4 description in following chapters).



# 3. EVENT SCENARIOS FOR PADDOCK AREA

Based on the most common measures put in place by most of the National Authorities, the **four scenarios** listed below are being considered for each Event.

Dorna is working simultaneously on all scenarios with Circuits and Authorities to ensure safe an environment for all participants and maximizing the Event attendance under all applicable rules.

Same as Paddock Family members, these special guests and spectators will have to follow the WorldSBK Contingency Plan and comply with all rules set. This includes full registry of such persons and Covid-19 Test to be carried out at the Circuit Gate prior to access the Paddock.

\*\*\* Applicable only in case National Authorities allow the presence of general public and guests without restrictions at Sports Events. In such case the access of public to Paddock Areas will be studied together with Event Organizers and will be subject to approval by Dorna.

# Paddock Access - Covid-19 Test Definition

As per relevant Event Scenarios, all participants will have to pass a Covid-19 Test to access the Paddock.

## Essential Staff under Scenarios 1, 2 & 3

- Essential Staff must present a negative Covid-19 Test PCR or Antigen carried out 72 hours prior to their First-time Paddock Entry.
- > No other Test types are accepted.





- An official certificate will be required either printed or shown on mobile device when performing the Firsttime Check In at the Paddock Gate.
- > This certificate must be presented by all essential staff, including national residents and participants staying in the relevant country previously to the Round date.
- In case essential staff members arrive form a different country and the Round hosting country requires relevant PCR or Antigen Test to enter the country, then this certificate will be considered as valid always when the participant enters the Paddock within 72 hours from the time the Test was carried out.
- In case the 72-hours' time limit is exceeded, the participant will have to carry out Antigen Test at the Test Station at the Circuit entrance.
- In case a positive Antigen Test is detected at the Circuit Laboratory, Control PCR Test will be carried out. Such person will have to stay isolated until the PCR result is available. In case the Control PCR Test is negative, a decision in compliance with the national rules, examining the case, by the CMO consulting the WorldSBK Medical Director will be taken. In case the Control PCR Test is positive, then Covid-19 positive protocol will be activated as per national rules. This person will not be allowed to enter the Paddock.
- > To ensure smooth entry operation, Dorna will provide PCR and Antigen Test Station at the entrance of all Circuits from Tuesday until Sunday.
- Additionally, all essential staff will also provide Self-Declaration to certify health conditions.
- In case the Covid-19 Test type should change, Dorna will inform all parties involved 30 days prior to the Event date, although in case any rule change is applied by national/local authorities, all participants will have to comply with the entry rules even if informed in shorter period before the Round date.

#### Registered Guests under Scenarios 2 & 3

- > All Guests must carry out an Antigen Test at the Circuit Gate prior to the First-time Paddock Entry.
- > No Covid-19 Tests carried out previously to Paddock Access will be considered.
- This rule applies also for Guests arriving from a different country to the Round hosting country even in case they carried out any Covid-19 Test for their travel purposes. All Guests will be required to carry out Antigen Test at the Circuit Gate.
- In case a positive Antigen Test is detected at the Circuit Laboratory, Control PCR Test will be carried out. Such person will have to stay isolated until the PCR result is available. In case the Control PCR Test is negative, a decision in compliance with the national rules, examining the case, by the CMO consulting the WorldSBK Medical Director will be taken. In case the Control PCR Test is positive, then Covid-19 positive protocol will be activated as per national rules. This person will not be allowed to enter the Paddock.
- > To ensure smooth entry operation, Dorna will provide Antigen Test Station at the entrance of all Circuits for all registered Guests.
- Additionally, all Guests will also provide Self-Declaration to certify health conditions.
- In case the Covid-19 Test type should change, Dorna will inform all parties involved 30 days prior to the Event date, although in case any rule change is applied by national/local authorities, all Guests will have to comply with the entry rules even if informed in shorter period before the Round date.

# **Registered Spectators under Scenario 3**

- All registered Spectators must carry out an Antigen Test at the Circuit Gate prior to the First-time Paddock Entry.
- > No Covid-19 Tests carried out previously to Paddock Access will be considered.





- This rule applies also for Spectators arriving from a different country to the Round hosting country even in case they carried out any Covid-19 Test for their travel purposes. All Spectators will be required to carry out Antigen Test at the Circuit Gate.
- In case a positive Antigen Test is detected at the Circuit Laboratory, Control PCR Test will be carried out. Such person will have to stay isolated until the PCR result is available. In case the Control PCR Test is negative, a decision in compliance with the national rules, examining the case, by the CMO consulting the WorldSBK Medical Director will be taken. In case the Control PCR Test is positive, then Covid-19 positive protocol will be activated as per national rules. This person will not be allowed to enter the Paddock.
- To ensure smooth entry operation, Dorna will provide Antigen Test Station at the entrance of all Circuits for all registered Spectators.
- Additionally, all Spectators will also provide Self-Declaration to certify health conditions.
- > In case the Covid-19 Test type should change, Dorna will inform all parties involved 30 days prior to the Event date, although in case any rule change is applied by national/local authorities, all Spectators will have to comply with the entry rules even if informed in shorter period before the Round date.

To avoid any doubts, these access rules as described refers to the WorldSBK Contingency Plan and Paddock Access.

In case any restrictions will apply for general public at the Grandstands / General Admission (unclean zone), those will be managed by the Circuit and relevant National/Local Authorities.

# Event Scenario 1 | Essential Staff only

- This scenario understands an Event held behind closed doors in the Paddock Area with essential staff only.
- All participants will be registered prior to the Event in order to be allowed to access the Paddock.
- > All participants will comply with necessary legal procedures.
- All participants will have to present a certificate of a negative Covid-19 test carried out a maximum of 72 hours prior to being allowed to access the Paddock.
- See above Test Definition for essential staff.
- Cost of the Covid-19 Test supplementary service at the Testing Facility at the Circuit Entrance will be communicated to each Team Manager/Company responsible in advance.
- Dorna's aim is to keep the cost of this testing at reasonable price for all stakeholders.
- > No interaction with general spectators, if they are allowed, will be permitted.

#### **Event Scenario 2** I Essential Staff + Limited Registered Guests

- This event scenario will allow the presence of a limited number of registered guests in Paddock Areas.
- > Championship stakeholders will be assigned with a limited number of passes which will be distributed between the Teams and Championship & Event Organizers' Partners.
- > The maximum number of guests applicable for each Team/Company will be communicated 30 days prior the Event.
- > All guests will follow the same registry process and will pass a Covid-19 test at the Gate as described above in the Test Definition.





- The cost of the compulsory Covid-19 Test carried out at the Testing Facility at the Circuit Entrance for all Guests will be communicated to each Team Manager/Company responsible in advance.
- **>** Dorna's aim is to keep the cost of this mass testing at reasonable price for all stakeholders.
- > It will be responsibility of each Team/Company to ensure all administrative registry being completed before the Event as well as to cover the cost of the tests performed to their respective guests.
- The movement of these guests will be restricted to the Paddock Area and exclusive reserved viewing area terrace / grandstand when available.
- > No interaction with general spectators, if they are allowed, will be permitted.
- > Each Team/Company will regulate access of these guests to their private areas and additional capacity rules will apply.
- The access of children will be allowed in case National Authorities permit presence of minors non-active participants at Sports Events. In this case the minimum age will be set by the National Authority and/or the minimum age of obligatory use of face mask in the country and/or World Health Organization. This information will also be confirmed 30 days prior the Event.
- This scenario is subject to any national regulations and/or restrictions which may come into force in a shorter time before the Event. In such case Dorna and the Event Organizers will have to follow those new rule(s) and guests may be refused to access the paddock. The aim of Dorna and Event Organizers is to avoid this situation to the maximum.

# Event Scenario 3 | Essential Staff + Limited Registered Guests + Limited Registered Spectators

- > This event scenario will allow the presence of a limited number of registered guests and a limited number of registered spectators in Paddock Areas.
- Championship stakeholders will be assigned with a limited number of passes which will be distributed between the Teams and Championship & Event Organizers' Partners.
- > The maximum number of guests applicable for each Team/Company will be communicated 30 days prior the Event.
- > The Event Organizers will put on sale agreed number of tickets for general public.
- All guests as well as all spectators will follow the same registry process and will pass a Covid-19 Test at Gate as described above in the Test Definition.
- > The cost of the compulsory Covid-19 Test carried out at the Testing Facility at the Circuit Entrance for all Spectators will be communicated to Event Organizer in advance.
- > Dorna's aim is to keep the cost of this mass testing at reasonable price for all stakeholders.
- > It will be responsibility of each Team/Company to ensure all administrative registry being completed before the Event as well as to cover the cost of the tests performed to their guests.
- > Event Organizers will proceed in the same way with registered spectators.
- The movement of these guests and spectators will be restricted to the Paddock Area and exclusive reserved viewing area terrace / grandstand when available.
- > Each Team/Company will regulate access of these guests to their private areas and additional capacity rules will apply.
- > It will fall upon each Team/Company to regulate access of these spectators in their private areas.
- > The Event Organizers shall enable relevant services for spectators authorized in the Paddock (such as restaurant/bar, toilets, cleaning etc.).





- The access of children will be allowed in case National Authorities permit presence of minors non-active participants at Sports Events. In this case the minimum age will be set by the National Authority and/or the minimum age of obligatory use of face mask in the country and/or World Health Organization. This information will also be confirmed 30 days prior the Event.
- This scenario is subject to any national regulations and/or restrictions which may come into force in a shorter time to the Event. In such case Dorna and the Event Organizers will have to follow those new rule(s) and guests and/or spectators may be refused to access the paddock. The aim of Dorna and Event Organizers is to avoid this situation to the maximum.

## **Event Scenario 4** I return to open Paddock

- > This event scenario will allow the return of all Championship participants as well as the presence of guests and spectators in Paddock Area.
- This situation will be considered from a global point of view based on evolution of the Covid-19 pandemic under indications issued by Governments and World Health Organization.
- Relevant restrictions and measures as set out in this Contingency Plan may be reversed. This presents a complex operation and therefore the full Contingency Plan (if applicable) will be released for the application of Event Scenario 4.

## **Event Scenarios Timeline**

- > Due to operation reasons and complex management of all facilities and staff involved, the applicable scenario will be communicated to Participants **30 days before the relevant Event**.
- Any scenario is subject to any national regulations and/or restrictions which may come into force in a shorter time before the Event. In such case Dorna and the Event Organizers will have to follow those new rule(s) and guests may be refused or accepted to access the paddock. The aim of Dorna and Event Organizers is to avoid this situation to the maximum.



# 4. ESSENTIAL STAFF

All participants <u>will be requested</u> to sign a self-certification of responsibility towards Covid-19 and the risks associated with their participation in the Event (Covid-19 Self-Certification) before accessing the Circuit.

Additional Covid-19 Tests may be applicable according to the Event Scenario.

Access to the event is forbidden to any person presenting any symptoms (fever, chest pain with or without dyspnea (shortness of breath), dry cough, gastroenteritis / diarrhea, asthenia (unusual tiredness), anorexia (decreased appetite), loss of taste or smell and/or others according to the updated local official regulations / indications about Public Health related to SARS-CoV-2 / COVID-19 disease that may be associated with Covid-19 and local residents should contact the Covid-19 service telephone number in their autonomous community or center primary care and follow their instructions. In the case of international participants, they will follow government orders and regulations in their country of residence before departure. These participants will not be able to go to the circuits until they confirm that there is no risk for them or for the others.

Access to the event is also prohibited for anyone who has been in close contact (cohabitants, family members and people who have been in the same place while the contact presented symptoms at a distance of less than 2 meters (6.5 ft) for a time of at least 15 minutes) or shared space without keeping the interpersonal distance with a person affected by Covid-19, even in the absence of symptoms, for a space of at least 14 days. During this period, you should monitor for signs of the disease.

Access to the event is also discouraged for anyone who is vulnerable due to age, being pregnant or suffering from previous medical conditions (such as cardiovascular diseases, diabetes, chronic lung diseases, cancer or immunosuppression) in case they cannot perform their tasks at a safe distance.

The entry of minors is prohibited, with the exception of the riders / team member participating in the competition in which case the presence of a legal guardian is mandatory, be it a parent or a team member duly delegated by the parents / legal guardians. See Event Scenarios details for further information for children accessing the Events.

If the person presents symptoms compatible with an acute respiratory infection, during his stay in the circuit the WorldSBK Medical Protocol will be followed, detailing all the steps from admission to the triage point, medical evaluation and possible transfer to the hospital. The WorldSBK Medical Protocol will be available 30 days prior the Event.

#### Teams

- Each Team will be provided with a maximum number of participants that will be determined by the applicable Event Scenario.
- In general, the same team limits as in 2020 will be applied with a minor increase to allow the teams to provide a catering service to all team members and to allow the presence of essential commercial staff. See chapter dedicated to teams' hospitalities.
- > No under-aged participants will be allowed with exception of riders; see Event Scenarios for details for further information for children accessing the Events.





- > All under-aged riders will be allowed to bring their companion and this person will be added to the team limits.
- Restrictions will be applied for specific areas, such as restricted access to the Starting Grid, Media Centre etc.

## Riders

- > All riders are considered essential staff and will undergo same access procedures.
- > It is rider's responsibility to ensure all necessary licenses are valid for each Event.
- > The usual medical examination to obtain the season license is a standard procedure obligatory for all riders.
- Furthermore, all riders will be asked to declare for each Event the following:
  - That he/she holds a valid rider's license (such as or equivalent to holding a valid start permission issued by the FIM and/or by its FNM) and said rider's license is fully valid and effective to enable him/her to participate and compete in the relevant Event(s).
  - Specifically, if the rider has been previously diagnosed with Covid-19, in case of temporary suspension
    of his/her rider's license and/or his/her medical certificate for competitive sport (as may be requested
    by his/her FNM), the rider will be asked to declare that his/her rider's license (such as or equivalent to
    holding a valid start permission issued by the FIM and/or by its FNM) has been re-activated, having the
    rider fulfilled all necessary requirements and assessments from the FIM and/or its FNM.
  - This declaration is part of the FIM Superbike World Championship Self-Certification Form SARS-CoV-2/Covid 19 which will be available to all participants before the Event(s).
- > Please, make sure you have accurate information and prepare all documents before the Event to avoid any problems at the Circuit(s).

# **Racing Service Companies & Technical Suppliers**

Racing Service Companies and Technical Supplier will continue with essential staff only.

# Media & TV Broadcasters

- > A limited number of permanent, international and national media and TV broadcasters will be allowed.
- > All media and TV representatives will follow the same access registry as all essential staff.
- > Dorna will continue with virtual media interaction service for all media.

# Organization

- Race Officials, Event Organizers as well as Dorna will follow the policy of strictly essential staff attendance at the Circuits.
- > The necessary technical resources will be implemented in order to carry out meetings without them being face to face, to comply with the social distance protocol and to allow the remote work of the staff not present at the track (briefings, meetings, hearings, official statements etc.)



# 5. TRAVEL AND ACCOMMODATION

Each company will be in charge of organizing the travel and accommodation of their staff for the event as per normal circumstances. It is suggested to accommodate all staff at hotels adapted to Covid-19 conditions.

It is also recommended for all staff to take breakfast, lunch and dinner in the hotel where the staff is accommodated to avoid unnecessary exposure in other locations, alternatively use catering services at the Circuit.

It is recommended that all participants authorized to stay overnight within the circuit during the event shall be restricted from leaving the venue at night. They will undergo the temperature control and / or the medical controls established every morning at the Circuit's medical facilities.

Dorna is in constant contact with the relevant authorities to observe the evolution of the current restrictions for people and materials within the country borders. Dorna will try to manage the special permissions for all the attendees in case there are still some restrictions as the date of the event gets closer. Dorna will do its best to inform the teams, from time to time, of any travel restrictions that paddock staff might face.

Individual supporting letters shall be requested by the affected staff to Dorna WSBK Organization at least 15 days prior to the planned trip. Any and all letters will only be provided in relation to the participation in the Rounds, not for any private testing.

The possibility that some nationalities/residence countries will require a quarantine period upon their arrival to a country will be evaluated enough in advance, so as to plan the staff's travel.

# PCR / Antigen Testing for travel purposes

- Dorna is also monitoring specific requirements implement by different countries to return to their residence after the Round(s). In case PCR / Antigen testing for return travel purposes will be required, Dorna and/or the Event Organizer(s) will provide an on-site Testing Facility. Any and all test costs for travel purposes will be covered by each Company for its Participants.
- > Relevant information will be provided to all Team/Company responsible.



# 6. MEDICAL PROTOCOL - MEDICAL TEST SYSTEM COVID-19

## Before the Event

- If the specific PCR Covid-19 negative test is implemented by IATA or at arrival by the authorities of the country, it may then fulfil all access requirements for the event in Circuit entry is done within the time period set by the Contingency Plan.
- As per Event Scenarios and the Covid-19 Test Definition, different Covid-19 test criterion will be applied to relevant collectives differing essential staff from potential limited number of registered guests and limited number of registered spectators.
- > A Covid-19 Self-Certification Form must be completed and signed by each participant attending the event.
- > Dorna will continue monitoring all Government requirements as well as any other possible alternatives to guarantee the safest measures. In due course we will inform all participants/attendees of the specific requirements applicable for each event going forward.
- In the same way Dorna will continue monitoring the evolution on vaccination progress and/or any new technology that can be implemented to ensure the measures set in place keep providing safe environment also from global calendar point of view, not focusing only on a single event operation.

# **Medical Data**

The management of all these medical tests and data will be carried out by the medical commission of the championship or by a testing laboratory appointed by DWO or Event Organizer(s), and it will require the individual authorization of each of the participants. The official hospital of the event and the Medical Centre of the circuit will be prepared to handle participants with Covid-19 symptoms.

# **Clinica Mobile**

- > The Clinica Mobile in the event will provide standard services but will give priority to rehabilitation sessions for riders with racing-related injuries.
- The Clinica Mobile will be responsible for organizing the schedule for massage/recovery service sessions under relevant Covid-19 prevention measures.

#### Temperature Check for participants overnight in Paddock

- All participants who are authorized to stay overnight within the Circuit/Paddock will undergo mandatory temperature screening every day/morning.
- > The list of these participants will be generated automatically based on Paddock electronic Access Control registry.
- > Failure by any of the team member(s) to this temperature control will result in the implementation of a sporting penalty to all riders of relevant team.



- The morning temperature control check point will be clearly signposted, at most of the Circuits will be located at the Technical Bay.
- From 28th May, the schedule for the temperature check is as follows:
  - Wed & Thu: 09:00 10:00 h
  - Fri, Sat & Sun: 07:00 09:00 h
- > The morning temperature control check will be performed by Circuit Security Staff.

For more information on medical procedures, please check the WorldSBK Covid-19 Medical Protocol (Annex 1).



# 7. NEW OPERATION FOR PADDOCK ACCESS

Paddock access will be restricted to the essential staff from each company, with proper authorization and they should not access the track until they are required to carry out their event duties.

For Event Scenarios 2 and 3, Guests and/or Spectators will only be allowed to access the Paddock on Saturday & Sunday.

In order to be able to fulfil entry regulations set for different Event Scenarios in a very short period of time, a new digital tool is being developed by Dorna.

## **Granting Access to Paddock**

- > Only participants who fulfil all registry and access requirements will be granted with Paddock Access.
- Owning any WorldSBK credential itself, without satisfactory fulfilment of access requirements, will not grant access to any Paddock Area.
- > Permanent pass holders will have to comply with access requirements for every Event.
- Access Requirements will be marked by relevant Event Scenario.

## Participants Registry & Pass Requests

- A new digital platform will be available to all Championship stakeholders.
- This new tool will introduce a Central Registry that will permit effective communication with all Teams/Companies responsible persons as well as electronic acceptance of different legal requirements.
- > This tool will integrate also a new pass request system.
- Relevant information will be provided to all stakeholders with sufficient time before the first Round of the Season.

# Participants' App

- > Together with the Central Registry a specific Participants' App will be introduced.
- > This mobile app will allow all participants to fulfil with legal and administrative obligations.
- Relevant information will be provided to all stakeholders with sufficient time before the first Round of the Season.

#### **Electronic Control at Paddock**

- A new electronic control will be set to access the Paddock Areas.
- Electronic control will start on Tuesday at 09:30 h and will be run continuously until Sunday 17:00 h.
- The pass collection point will be set at Circuit / Paddock Entrance.



# **Covid-19 Tests at Gate**

- In case a participant needs to take a Covid-19 test at the Gate, additional registry with the Testing Laboratory Partner Company will be required. Dorna will inform all team/company managers about all registry steps to be done prior to the arrival to the Circuit in order to speed up all process and minimize waiting time.
- For Overseas Rounds, it will be the Event Organizer(s) who will set up and provide necessary testing facilities for all participants and guests for any and all purposes when applicable.

#### Access Hours to Paddock

- > Participant identification and pass activation will be required when any participant enters the Paddock for the first time during an Event.
- Even for permanent pass holders this operation will take place at each Round.
- To facilitate your travel planning, please bear in mind the following schedule for Event First-time Registry is up-dated on 28th May:
  - Tuesday\*: 09:30 19:00 h
  - Wednesday: 08:30 19:30 h
  - Thursday: 08:30 19:30 h
- Friday\*\*: 07:30 18:00 h
- Saturday: 08:00 18:00 h
- Sunday: 08:00 14:00 h
- \* Entry time on Tuesday in case of back-to-back races may be delayed a few hours.

\*\* Friday entry time will be adjusted as per Event Time Schedule to ensure smooth entrance for Circuit Staff.

#### > No first-time entry will be possible out of these operating hours.

- Once completed the first-time entry registry, staff members will be allowed to exit the paddock as per normal conditions, however it will be advised that all paddock staff exit the premises before 22:00. Movements to/from outside the Paddock shall be limited to exceptional circumstances during the day.
- Access to the circuit between 22:00 and the opening hours (of the following day) should only be for emergencies, medical or justified reasons.
- Exit from the circuit between 23:00 and the opening hours (of the following day) should only be for emergencies, medical or justified reasons.
- All Guests and/or Spectators (Event Scenarios 2 and/or 3) must leave the Paddock Area before 23:00 h on Saturday. On Sunday all Guests and/or Spectators will leave after the last track and/or Paddock activity.

#### **Pass Collection Point**

- The Accreditation Centre as we used to operate it in the past will be replaced by a Pass Collection Point situated in the Paddock Check In Area applicable for Event Scenarios 1, 2, & 3.
- To facilitate your travel planning, please bear in mind the following schedule is being pre-set for the Pass Collection Point. Starting from 28th May, the Paddock Check In Schedule is adjusted to the following schedule:
  - Tuesday\*: 09:30 19:00 h
    - Wednesday: 08:30 19:30 h
  - Thursday: 08:30 19:30 h
- Friday\*\*: 07:30 18:00 h
- Saturday: 08:00 18:00 h
- Sunday: 08:00 14:00 h
- \* Entry time on Tuesday in case of back-to-back races may be delayed a few hours.



- \*\* Friday entry time will be adjusted as per Event Time Schedule to ensure smooth entrance for Circuit Staff.
- In case the Event Scenario 4 will be applied, the Accreditation Centre may be operated as in 2019. In such case all participants will be informed in advance.

#### Vehicles & Pedestrian access

- > There will be a clearly marked access to the track. All necessary steps and relevant facilities to comply with access rules will be indicated. The process will include body temperature scanning with social distancing and any other access requirement(s) set by the applicable Event Scenario.
- > There will only be one vehicle access to the track and the vehicle drivers will have had to complete the compulsory screening beforehand.
- > The vehicles used by the staff of each company to commute from their hotel to the track will be parked in a specific area outside of the controlled area of the paddock.

# Paddock Delivery

- A separate special paddock delivery system will be implemented. All parcels must be collected outside of the controlled premises. Information needed from the manufacturers as a forecast on how many deliveries they expect per event/day.
- Additional procedures will be applied for the food products delivery and specific logistics will be defined for each Round.
- In a case of food delivery, all drivers and supporting personnel must follow the same entry procedures as Participant Registry and if required by the Event Scenario, include fulfilment of a Covid-19 Test (a negative PCR or Antigen Test certificate) carried out with a maximum of 72 hours prior to the entry or Antigen Test at Gate).



# 8. TEAMS, RACING SERVICE, SUPPLIERS & TV BROADCASTERS

# Teams Working Trucks

- > It is envisaged that teams will use their working trucks as per usual in Europe and that the parking schedule for them will be provided prior to each Round.
- > Teams Working Trucks are considered the teams' private area and therefore each team/company is responsible to follow all prevention measures, including cleaning and disinfection.

## Pit Box Space

- > Paddock / Pit Box allocation will be sent separately before the event with sufficient time in advance.
- > Pit Boxes are considered the teams' private areas and therefore each team/company is responsible to follow all prevention measures, including cleaning and disinfection.

## Catering

- > It has been agreed that for the 2021 season, all eligible teams will be allowed to provide catering service to their team members with food for self-consumption only, always respecting all valid Health & Sanitary laws and/or rules as set by the relevant Authorities at each Event location.
- > Each team shall be responsible for catering for its own crew only, complying with rules and considering each individual team as family unit.
- In case any team wishes to provide a catering service to other teams/companies, then a separate schedule must be set to avoid the clash of members from different teams/companies at the same time. Disinfection of all areas will be performed before another group enters the hospitality area.
- > It is allowed to provide services for breakfast, lunch and dinner.
- > Take away format is preferable to be implemented.
- > Buffet service will also be permitted but strict prevention rules must be followed:
  - Buffet can only be served by specific catering staff no self-buffet is permitted.
  - Screen protections must be placed in front of buffet trays.
  - All catering staff must comply with all prevention measures and specific emphasis is given to the compulsory use of face masks in the kitchen and all other areas.
  - Disinfection of all crockery and kitchen equipment must be performed after each use.
- > Paddock Delivery for food will be allowed as per standard delivery times.
- Under Event Scenarios 2 & 3 when Guests will be permitted, hospitality processes shall be adapted. It is recommended to set additional time slots for Guests. Capacity, social distancing, seating order and all other prevention measures must be followed. In any case it will fall upon the Team/Company to allow Guests and Team/Company members eating at the same time slot if the capacity limit permits such execution.



## Team/Company Hospitality / Catering Areas

- > All areas dedicated to the catering service must comply with the key rules set by the Championship organization as well as any additional ones in case any National Authority requires so.
- > Compulsory minimum requirements for catering areas:
  - Area Capacity will be calculated with a basic criterion of 4 square meters (43 square feet) per person with no exceptions.
  - Natural ventilation with adequate air flow must be ensured with internal air renewal at least six times per hour.
  - In case of not being able to carry out adequate natural ventilation, air purifiers with HEPA 13 or HEPA 14 filters must be available. According to the UNE 1822 standard, these purifiers must have a highly efficient air filtration, with the capacity to retain aerosols in percentages over 99.95%. These purifiers must have the capacity to renew the air of the entire hospitality six times an hour.
  - Alternative solutions to HEPA filters in case of not being able to carry out adequate natural ventilation, such as use of high power UVC germicidal lamps, fan coils and similar can also be considered but bear in mind its use and possible medical contradictions for specific people with asthma and/or other allergies. In case you decide to implement any alternative solution make sure to have all relevant official certificates.
- > All teams/companies wishing to set up a hospitality unit must contact Dorna in advance and fulfil the relevant questionnaire related to the Covid-19 prevention measures application.

#### Motorhomes

- > Only for the riders as per current rules.
- > Team Units can be used for a limited number of team personnel.
- > All attendees authorized to stay overnight within the circuit during the event will be restricted from leaving the venue at night.
- > All attendees authorized to stay overnight within the circuit are requested maximum responsibility and must avoid any movements outside the Circuit with exceptions of medical emergencies.
- > It is recommended that all attendees authorized to stay overnight within the circuit arrange their breakfast/lunch/dinner through the authorized catering units.
- > All attendees authorized to stay overnight within the circuit will undergo the temperature control and / or the medical controls established every morning at the Circuit's medical facilities.
- As per the restrictions applied to essential personnel, the person driving rider's motorhome should be someone from the Team nominated list.
- As usual, a confirmation e-mail with the rider's motorhome presence or not would have to be sent to Dorna Paddock Manager.

#### **Teams Offices**

> Teams Offices are considered teams' private areas and therefore each team/company is responsible to follow all prevention measures, including cleaning and disinfection.



#### Service Companies

- > Service Companies may bring their vehicles.
- Service Company staff should remain with their vehicle and members of teams visit them to collect and drop off leathers, helmets etc rather than the service company staff going from team to team delivering them. Obviously, Dorna appreciate that there are some exceptions, with the technicians from certain companies having to be present in a teams' pit box for operational purposes.
- > All Service Company areas are considered the companies' private areas and therefore each company is responsible to follow all prevention measures, including cleaning and disinfection.

#### Suppliers

> All Suppliers areas are considered companies' private areas and therefore each company is responsible to follow all prevention measures, including cleaning and disinfection, even if allocated in permanent circuit facilities.

#### *Teams/Companies private toilets*

In case of having private toilets/showers in any of the private areas as described above, those are considered private areas and therefore each company is responsible to follow all H&S measures, including cleaning and disinfection.

#### **TV** Broadcasters' Mobile Units & Commentary Positions

- > All TV Broadcasters Units, if authorized by Dorna, are considered companies' private areas and therefore each company is responsible to follow all prevention measures, including cleaning and disinfection.
- > Bearing in mind specific technical set up and delicate equipment, the TV Commentary Booths cleaning and disinfection will be carried out by the TV Broadcasters or upon an agreement by Dorna TV staff.
- > The Event Organizers will only be asked for standard cleaning in the TV Commentary Booths (floor sweeping, bins removal, window cleaning) without any contact with the technical equipment set at the commentary position.
- > Special emphasis is given to use of adequate PPE by all staff inside the mobile units and/or commentary booths.
- Understanding limited workspace area being used for live broadcast and limitation of natural ventilation, adequate ventilation system needs to be considered see recommendation in the chapter related to Teams/Companies' Hospitalities.



# 9. PROCEDURES

# Working in the Paddock

- > Upon entry to the paddock, staff will be obliged to go straight to their workplace, which they will only leave for justified reasons (work, bathroom, lunch etc.)
- > Interaction with members of other teams/companies should be avoided and only for professional reasons.

# Technical Bay & Technical Box

- > Maximum of 2 team members per bike will be allowed to access the Technical Box.
- > All persons must wear their Personal Protective Equipment (hereinafter referred to as the "PPE") at all times and the social distance rule shall be applied always when technical control procedures allow it.
- > The Technical Bay area will be enlarged to comply with the social distancing rule.
- > Spots will be marked on the surface.
- In a specific case that Technical Officials have to perform any verification inside the teams' box/area, they will always wear PPE at all times. In case any assistance from any team member is needed, use of PPE is obligatory.

# Parc Fermé

- > Parc fermé will be located in the Pit Lane.
- It can be re-located to a special area set up close to the Paddock Show under the Event Scenarios 2 & 3. The position is subject to Dorna discretion.
- > Parc fermé will be reduced to a maximum of 2 team staff per rider and all must wear their PPE.
- > Interviews to the riders will be run with social distancing.
- From 28th of May, riders will conduct TV Live Parc Fermé interviews without the obligation of wearing a face mask. This special permission is granted only for the DWO official live camara. Once interview finished, riders will wear their mask.
- Interviews with other broadcasters, if allowed their presence in the Parc Fermé, will be conducted with riders wearing face masks. All other interviews remain with the obligation of wearing a face mask.
- > Interaction with members of other teams/companies should be avoided and only for professional reasons.

#### Grid

- > There will be strict limitations to attend the grid, which will only be allowed for essential personnel as follows:
  - WorldSBK: 6 persons of team crew + team manager / each rider;
  - WorldSSP: 6 persons of team crew + team manager / each rider;
  - WorldSSP300: 6 persons of team crew + team manager / each rider;
- > There will not be grid girls/boys, however it will be allowed for a team member to hold an umbrella.
- All persons that will be authorized to enter the grid must wear their PPE, even in case they can maintain the social distance of 2 meters (6.5 ft).





- Remember use of any face mask (FFP2, surgical or hygienic) must always be accompanied by face shield or alternatively by glasses (any type – work googles, sunglasses or dioptric glasses).
- > It is forbidden to take any group photos where the minimum distance cannot be secured.
- From 10<sup>th</sup> of June cancelled: In case the rider takes off the helmet, he/she must wear a mask immediately and substitute by:
- From 10<sup>th</sup> of June once rider arrives on the starting grid and takes off the helmet, he/she can stay without a face mask while seated on the bike. In such case all team members staying in a distance less than 1 meter (3.3 ft) from the rider must wear an FFP2 face mask accompanied by face shield or alternatively by glasses.
- In case Event Scenario 2 or 3 will be applied, a strictly limited number of guests may be allowed to access the Starting Grid. In such case, all guests must comply with all prevention measures as above.

## Signalling Pit Wall

- Only limited number of team personnel as currently set to 4 persons per rider with appropriate credentials
   will be allowed to access the Pit Wall Canopy.
- > All persons must wear their PPE at all moments and if possible, they should maintain the social distance of 2 meters (6.5 ft).
- The type of PPE to wear will be marked by the real distance between the persons assisting at the Pit Wall Canopy.

# Podium

- > The Podium will be located in the permanent circuit facility.
- It can be re-located to a podium stage set up at the Paddock Show stage under the Event Scenarios 2 & 3.
   The position is subject to Dorna discretion.
- > The presence of podium girls/boys will be possible in the Event Scenario 2 & 3 and only in case the podium facility permits to comply with prevention measures, especially with social distance.
- > Pre-podium and podium procedures will be adapted to prevention measures, including disinfection of the trophies and bottles.
- > Interviews to the riders will be run with social distancing.

#### **Notifications & Information**

- > The intention is to not to deliver penalties in hand in the Pit Lane.
- > Penalties will be emailed to the team with an obligatory read-receipt.
- > Dorna will not print the results, they will simply be emailed to each team.



# **Rider Hearings & Briefings**

- > Dorna is planning to ensure distancing between the rider and the stewards so that hearings can be conducted in a normal manner.
- > The proposal for the Season Opening Briefings is to be to carried out as per normal in a space which allows for social distancing (+PPE), if not it would either be digitally, or divide the briefings into groups to allow social distancing.

# Local Staff & Marshals with Paddock Access

- > Even though all local staff and marshals will undergo the same screening upon entrance to the venue (including registry and the Covid-19 Test applicable rule), the plan is to minimize as much as possible the contact (social distancing) between local staff and Championship staff, when the circumstances won't allow for this, it will be obligatory to use PPEs.
- > With these measure in place, it is thought that these processes (trackside service, marshals, recovery, cleaning, meetings etc.) can be carried out as per normal. For technical scrutineering, measures and timetables will be put in place to minimize contact and risks between circuit and Championship staff.
- > Special emphasis is for those marshals/local technical scrutineers who access the grid. All persons must follow the Grid PPE assignment see subchapter Grid on previous pages.

#### Riders - Interaction with Media

- Access to the Circuit will only be granted to a certain number of Television Broadcasters accredited by Dorna and minimum photographers and/or other media.
- > The Media Department will continue with remote systems to carry out all the rider and team managers' media interactions (interviews, one-on-ones) to offer a good service to all the media covering the event while respecting the distancing regulations.
- > The protocols will be adapted according to the distancing regulations for the podium, parc fermé and interviews.

#### Media Centre

- > Access of press in general will be restricted to limited number media duly accredited by Dorna.
- > The National Press Officers, together with Dorna will work on specific strategy for national media allowing a limited number of media, duly accredited by Dorna.
- All representatives of media will have to follow all the rules, plans and protocols set for all participants and provide themselves with their own Personal Protective Equipment.
- > The usual media centre will be transformed into a media distribution center where the teams will have the facilities to conduct individual interviews with the media around the world virtually and still be able to meet contractual commitments with their partners.
- The Circuit will prepare the press room so that the accredited media can have a place at the tables at least 2 meters (6.5 ft) from each other.





- Every time a person enters or leaves the press room, they should wash their hands with hydroalcoholic gel, which will be made available by the Circuit.
- > The ventilation of the room will be a priority, as long as the facilities allow it.
- > It is advisable to reinforce cleaning tasks in all rooms at the end of the day, with special emphasis on surfaces, especially those that are most frequently touched such as doors, their knobs, all commonly used appliances, from light switches to tables.
- > To facilitate the cleaning and disinfection, all media will clear their working place as much as possible when leaving the room. The cleaning and disinfection of this common space will be carried out by the Circuit staff.

# **Race Direction Operation & Meetings**

- > Only a strictly minimum number of officials will be allowed to enter the Race Direction.
- As permanent installation, the Circuit will be in charge of the prevention measures. In case the minimum social distance cannot be guaranteed, the type of PPE must be relevant to real distance.
- > All personnel must follow all prevention measures.
- > All personnel will be responsible for their own working equipment and shall collect all personal belongings once the activity is finished to allow full cleaning and disinfection to be run.

#### Starter

- > Only a strict minimum number of officials will be allowed to enter the Starter Position.
- > All persons must wear PPE at all moment at all sessions.

#### Timing

- > Only personnel carrying out their work and Race Direction may enter the Timing Room.
- > Before entering the room, all persons must clean their hands with hydroalcoholic gel that the circuit will make available.
- All people must wear their Personal Protective Equipment at all times, although it is recommended to maintain a distance of 2 meters (6.5 ft) between people.
- > The Timing Staff must avoid, as much as possible, the use of equipment, pens, microphones for Walkies or transmitters and devices of other workers.
- > It is convenient to reinforce at the end of the day the cleaning tasks in all the rooms, with special incidence on surfaces, especially those that are touched more frequently such as doors, their knobs, all the devices in common use, from light switches to tables and computers.
- Every time a person enters or leaves the timing room, they should wash their hands with hydroalcoholic gel that will be made available by the Circuit.
- > Ventilation will be a priority as long as the facilities allow it.
- > To facilitate the cleaning and disinfection, all staff will clear their working place as much as possible when leaving the room.
- > Each person will be responsible for their own material.



## **Organization offices**

- > All persons in the offices must carry their Personal Protective Equipment at all times.
- > Before entering the room, hands will be cleaned with hydroalcoholic gel.
- > Ventilation in the room will be a priority as long as the facilities allow it.
- > The movement of personnel between different offices will be avoided and the flow will be allowed only for work reasons.

## Offices with attention to riders and teams

- > All persons who are in these types of offices must carry their Personal Protective Equipment at all times.
- > Before entering the room, hands will be cleaned with hydroalcoholic gel.
- > Ventilation in the room will be a priority as long as the facilities allow it.
- > People who wait to enter must respect at least the safety distance of 2 meters (6.5 ft) with other people and control mechanisms will be enabled and thus guarantee the safety distance between these people.
- > To minimize possible overcrowding of the office, appointment times will be established as long as sports operations allow it.

## Paddock Show

- > The Paddock Show will not be set up under the Event Scenario 1.
- > It will be up to Dorna discretion to set up the Paddock Show for Scenarios 2 & 3.
- > In such case all prevention measures must be followed both on stage & backstage.
- Guests' access to participate at the Paddock Show will only be possible with seating set up under social distancing rules. The number of guests for each Show will be restricted according to the approved capacity.
- > In case any **Autograph session** will be authorized following key rules will apply:
  - Waiting queues will be organized with social distancing.
  - Riders must wear an FFP2 mask.
  - Guests and spectators must wear an FFP2 or surgical mask.
  - For the autograph signature, all riders will use their own pens / markers only.
  - No selfies / photos with contact between the riders and guests/spectators are allowed.

#### Pit Lounge & Permanent Corporate Hospitality

- > The Pit Lounge & Corporate Hospitality operation will be ruled by its location at the Circuit and relevant access points.
- In case the hospitality area location permits access of guests from outside of the Paddock Area (unclean zone) and all set up can be done from outside, as well as there is no connecting way to enter the Paddock, then both Pit Lounge & Corporate Hospitality can be opened under any Event Scenario. They will be considered as Unclean Zone. It will be up to the Event Organizer to obtain necessary authorizations and/or permissions from relevant Authorities.
- In case to access the hospitality area guests and staff have to access through the Paddock Area (clean zone), then it can be opened only under Event Scenarios 2 & 3. In such cases, all guests as well as all staff will pass same the registry and take a Covid-19 Test at Gate.
- > In any case, the hospitality areas must comply with all prevention measures and capacity limits.



# Activation Programmes: Safety Car Laps & Test Drives

#### Programme authorization under Event Scenario 1:

- > Track activity involving **test drives** may be allowed under scenario 1. In such case the drivers and guests will enter and leave the car at unclean zone without any interaction with Paddock.
- > Activity will be run by professional drivers and/or instructors.
- > Maximum occupancy is set to a driver with 2 passengers.
- > All drivers and/or passengers will be wearing FFP2 face mask.
- > All cars will circulate with windows partially opened.
- > Disinfection will be after each use.
- > Registry of all passengers will be done.

#### Programme authorization under Event Scenarios 2 & 3:

- > Track activity involving **safety car laps** and/or **test drives** may be allowed under scenarios 2 & 3 and interaction with Paddock will be permitted.
- Guests and/or Spectators will be fully registered, and all will pass obligatory entry processes, including Antigen Test at Gate.
- > Activity will be run by professional drivers and/or instructors.
- > Maximum occupancy is set to a driver with 2 passengers.
- > All drivers and/or passengers will be wearing FFP2 face mask.
- > All cars will circulate with windows partially opened.
- > Disinfection will be after each use.
- > Registry of all passengers will be done.

Dorna may opt to work with Test Drive operation as described in Scenario 1 also under scenarios 2 & 3. In such case, no interaction with paddock will be permitted and same criterion will be adopted for the whole Event.

#### **Cleaning Services**

- > All cleaning services and disinfection brigades will follow the Circuit prevention plan.
- > All persons must wear PPE at all moment.

#### Waste Management

- > Waste management will follow the Circuit prevention plan.
- > It is strongly recommended to use of bins with a lid.



# 10. COVID-19 HEALTH AND SAFETY PLAN

#### General framework of preventive measures and minimum distance

- > As a general rule, the optimal way to prevent transmission of the virus is to use a combination of all preventive measures, not just Personal Protective Equipment (PPE). The application of a combination of control measures can provide an additional degree of protection.
- As a general measure, use of Personal Protective Equipment is mandatory within the Circuit Facilities. The type of the PPE must be adequate for the activities and work to be carried out see detailed information below. A safety distance of 2 meters (6.5 ft) is established between people.
- > Whilst trying to minimize as much as possible the contact amongst all participants, the philosophy behind the proposed plan is to think about the members of each team/company as family units. It's empirical that contact between members of different teams/companies is avoided.
- As explained above, the current approach is based on recommendation from the Medical Commission for the paddock to have absolute control of all the personnel movement once they have arrived at the event. It is recommended that the movement of the people participating in the event is limited to the circuit and hotel. Even if the region where the event is held is in a phase that allows restaurants and retail to be operative, the recommendation is to avoid interaction with other people as much as possible and therefore it is recommended that the paddock community follow a strict lockdown policy.
- > As well as being allowed to exercise individually at the hotel (if hotel installations are adapted), participants will be allowed to exercise individually at the circuit (on track) at times without track activity.
- > Each company is free to develop its own Prevention plan outlining the safety measures and procedures according to their operations, however all participants will have to meet at least the minimum requirements and measures set out by Dorna.
- Each company must assign a member of its team as responsible for Health & Safety (H&S) who will be in charge of the correct implementation of the protocols defined in the technical prevention plan and will be the main contact for the Covid-19 Contingency Representatives from Dorna, circuit and local authorities.
- > Each company will be in charge of obtaining the necessary PPE (Personal Protective Equipment) for the protection of its employees.
- > Each company will be in charge to install the required hand sanitizer dispensers in their private working areas.
- > Each company will be responsible for the hygiene and daily disinfection of their team's private areas:
  - Vehicles and work structures inside the paddock;
  - Pit Box;
  - Offices;
  - Catering units.
- > All people (including the riders) who are authorized to stay overnight within the circuit premises during the event will be subject to exit restrictions during the night hours. They will also be obliged to carry out body temperature checks at the Medical Facilities each morning.



# Personal Protection Equipment (PPE)

- > The basic rules of social distancing, personal hygiene and use of personal devices will always be applied once they have accessed the circuit.
- > The social minimum distance set in the WorldSBK Contingency Plan is 2 meters (6.5 ft).
- > The Personal Protective Equipment is set to:
  - Type of face mask according to the job to be performed;
  - Facial screens or glasses at certain jobs performed.
- > As per current status, following use of PPE is obligatory:

Social distance	Obligatory Personal Protective Equipment
<b>0 - 1 meter</b> 0 - 3.5 ft	Face mask non-valved FFP2* + glasses or facial screen. * <b>In ventilated areas:</b> an FFP2 mask can be substituted with surgical mask or hygienic mask.
<b>1 - 2 meters</b> 3.5 - 6.5 ft	Face mask either surgical or hygienic or non-valved FFP2 + glasses or facial screen.
<b>More than 2 meters</b> More than 6.5 ft	Face mask either surgical or hygienic or non-valved FFP2.

- > All masks must have certification / technical specifications according to these approved quality standards:
  - FFP2 mask: UNE EN-149;
  - Hygienic mask: UNE0064 and UNE0065;
  - Surgical mask: UNE EN 14683.
- In case teams/companies have personalized hygienic masks, equivalent to FFP2, and intend to use them during the Events, COMPULSORY measures must be put in place specifications and certifications must be submitted to Dorna Covid-19 Contingency Responsible for verification and authorization in order to use them.
- > All teams/companies must present, upon request from Dorna Covid-19 Contingency Responsible, relevant documents certifying the mask quality standards.
- > Wearing a face mask is obligatory within the Circuit, including all common areas such as the paddock, bathrooms, service road etc.
- At all times when social distancing is not possible (working on the bike, inside the box, team meetings etc.) all paddock personnel will be obliged to wear PPE (face mask + glasses or facial screen depending on the distance).
- > Access to the Starting Grid will only be allowed with a face mask and glasses or facial screen.
- > In general, riders may not share any personal material with anyone.
- > Riders will not share drinks, other foods or other products, including sanitary or first aid.
- > All riders when not wearing a racing helmet will follow all rules set for all the participants at all time.
- > Handwashing, even with protective gloves, is very often the best infection-breaking system.
- > Medical Personnel will follow specific rules set in the Medical Protocol and supplied by the Circuit.
- > The track marshals, the track medical services and technical control scrutineers will be equipped with PPE to carry out their duties within the technical prevention plan. These will be supplied by the Circuit.



## **Group Prevention Systems**

- > The distribution of the operational areas will be done according to the Contingency Plan.
- > Temperature control in the circuit's main access point see diagram at Annex 3.
- > There will be hand sanitizer dispensers in the common areas.
- > There will be specific Covid-19 signs to inform and remind about the protocols and protection systems.
- > There will be signs to indicate and ease the flow through common areas keeping the safety distance.
- > Staff will only be allowed to move outside their private work areas if required by their specific duties.
- > There will be specific containers for single-use sanitary waste.
- > There will be a special management of cleaning and disinfecting brigades for the common areas.
- Common toilet and showers units will be scaled according to the paddock population and disinfection procedures.



# 11. GENERAL RECOMMENDATIONS

- Comply with all the preventative measures indicated in the Contingency Plan for SARS-CoV-2 of the Organization.
- Always wear Personal Protective Equipment, remember use of a face mask is mandatory at all areas at the Circuit. Type of the mask and additional PPE depends on the social distance and job performed.
- > Maintain the interpersonal distance (2 meters / 6.5 ft).
- > Avoid greeting with physical contact, including shaking hands etc.
- > Avoid, as far as possible, using other equipment and devices. If necessary, increase precautionary measures and, if possible, disinfect them before use. If this is not possible, wash your hands immediately after using them.
- > Frequently wash your hands with soap and water, or with a hydroalcoholic solution. It is especially important to wash after coughing or sneezing or after touching potentially contaminated surfaces. Try to make each wash last at least 40 seconds (see Annex 7).
- Cover your nose and mouth with a disposable tissue when you cough and sneeze, and then dispose of it in a closed trash can. If scarves are not available, use the inside of the elbow to avoid contaminating the hands.
- > Avoid touching your eyes, nose, or mouth.
- > Facilitate the work of cleaning staff when leaving an area, clear as much as possible.
- > Throw away any personal hygiene waste especially disposable tissues immediately into waste baskets or lidded containers.
- > Periodic ventilation tasks must be carried out in workplaces such as boxes, trucks, etc. and also in places where we spend the night, at least, daily and for five minutes.
- If the person presents symptoms compatible with an acute respiratory infection, during their stay at the circuit, a surgical mask will be put on, contact the Chief Medical Officer via your assigned person in charge of Health & Safety and the established protocols will be followed.

# **MEDICAL COMMISSION MEMBERS**

Exceptionally due to the Covid-19 pandemic, the MotoGP & WorldSBK Medical Commission have developed a new protocol, which going forward will be put into action. Each point will be reviewed and approved by the Medical Authority of each Circuit (CMO) and in turn follow the regulations of the Health Authorities of each country.

#### MEDICAL COMMISSION MEMBERS:

- > Dr. Ángel Charte, ph D.: Medical Director, MotoGP<sup>™</sup> World Championship.
- > Dra. Monica Lazzarotti: Medical Director, Motul FIM World Superbike Championship.
- > Dr. Giancarlo Di Filippo: Medical Officer, MotoGP™ World Championship.
- > Dr. Michele Zasa: Medical Director, MotoGP<sup>™</sup> and WorldSBK Clinica Mobile.

# **MEDICAL PROTOCOL - MEDICAL TEST SYSTEM COVID-19**

#### **Covid19 Positive Case Suspicion**

Covid19+ or symptomatic patient management protocol will follow local regulations. Any participant presented any symptom during the Event must inform immediately the Team's/Company's Health and Safety Person in charge who will contact immediately the WorldSBK Medical Director and/or the Circuit CMO (Chief Medical Officer).

#### Important

> The message from the Medical Commission is for the paddock to have absolute control of all the personnel movement once they have arrived at the event. It is recommended that the movement of the people participating in the event is limited to the circuit and hotel. Even if the region where the event is held is in a phase that allows restaurants and retail to be operative, the recommendation is to avoid interaction with other people as much as possible and therefore it is recommended that the paddock community follow a strict lockdown policy.

# MEDICAL PROTOCOL - FACILITIES ON-SITE COVID-19 MEDICAL TEST

- In case the WorldSBK Medical Director considers it necessary, Covid-19 Medical Tests will be done on-site at the Circuit.
- > Do not confuse this Medical Protocol requirement with the new Paddock Entry Operation. These are two independent operations.
- It will be upon the decision of the WorldSBK Medical Director and CMO to decide whether Certified Laboratory services will be supplied by the Organizer as part of the standard Medical Services. In such cases, the CMO and/or WorldSBK Medical Director will be the only persons authorizing any Test to be carried out and it will only be available to suspicious patients.





- > The WorldSBK Medical Director and CMO may decide to use the Testing Facility set at the Circuit Gate for participants bearing in mind restricted opening hours and approximately 24 hours results notification.
- In any of the above cases, the Circuits will provide necessary facilities, composed by an isolated room to be used as Medical Triage point and annexed, but fully separated, isolation room. Both rooms must be equipped with air-condition and window(s)/doors that permit regular ventilation. Exact facilities and location will be assigned and confirmed between Dorna and each Circuit.

# MEDICAL FACILITIES: CLINICA MOBILE (CM)

## a. Staff

The staff will be adapted to the Clinica Mobile maximum allowed capacity.

The staff will consist of:

- 2 doctors (1 for general medicine, 1 with experience in traumatology);
- A minimum 2 physiotherapists.

# b. Services and activities

The medical activity will be the same as usual, providing attention both to paddock members and to riders.

The Clinica Mobile in the event will provide standard services but will give priority to rehabilitation sessions for riders with racing-related injuries.

The Clinica Mobile will be responsible for organizing the schedule for massage/recovery service sessions under relevant Covid-19 prevention measures.

In case of crash, a doctor from the Clinica Mobile will go to the Medical Center as usual.

It will be important to communicate to the teams and stress the concept that their workers will have to travel only if they are 100% fit; otherwise, they will keep busy the Clinica Mobile for issues that should have been solved at home, increasing the risks inside the Clinica Mobile.

In collaboration with the Chief Medical Officer (CMO) a triage point will be appointed. The Medical Commission recommends to assigning only one unique triage point for both Medical Center (CMed) and Clinica Mobile. In any case the personnel for the triage point will be under the responsibility of the Medical Center.

**Patients will be screened for temperature, saturation and symptoms**. If the patient shows a T <37,5°C and with no relevant symptoms, the patient will be admitted in Clinica Mobile.

In any case no respiratory airways symptoms will be treated in Clinica Mobile. Patients with compromised temperature and/or saturation values, together with patients with relevant symptoms for Covid-19 infection (cough, respiratory



airways disease, lack of taste and/or sense of smell) will access the isolation room, where they will be supervised by the CMO and FIM WorldSBK Medical Director.

Access to Clinica Mobile will be by fixed quotas. Riders will be allowed to book their treatments, and no more than 2 patients will attend physiotherapy/rehabilitation at the same time. No more than 3 patients will be allowed to access Clinica Mobile at the same time. The number of patients attending Clinica Mobile for medical reasons will depend on the occupancy of the Clinica Mobile in that specific time.

#### No patients will occupy the waiting area in Clinica Mobile; they will rather wait their turn outside.

It will be ensured a minimal distance of 2 meters (6.5 ft) between 2 beds inside Clinica Mobile.

# c. Protective clothing

Patients arriving to Clinica Mobile will be given a mask, some hand sanitizer gel to clean their hands.

Should they already have a mask they will keep it. They will keep the mask throughout their stay in Clinica Mobile.

Bearing in mind that how you use Personal Protective Equipment (PPE) is far more important than what you use, Clinica Mobile personnel will wear FFP2 masks, face shields (optional), disposable gowns or working suits that will be kept for a whole work shift.

During treatments personnel could use gloves (to be thrown away after each treatment) or bare hands (to be washed with water and soap immediately after the treatment).

Following each patient treatment, the surface touched by the patient will be sanitized by the member of the staff who treated the patient. Sanitizing will be performed using specific alcoholic solutions (over 70% alcoholic) sprayed over the surfaces.

At the end of the working day, all the Clinica Mobile surfaces will be sprayed with the same solution or other disinfectant wipes or hypochlorite etc.

# MEDICAL FACILITIES: MEDICAL CENTER (CMed)

Together with the circuit CMO Questionnaire the CMO will send to the WorldSBK Medical Director a specific document that will include Medical Center Internal Guidelines procedures focused on COVID-19 prevention (healthcare environment/ patient treatment).

Medical/paramedical staff: same as all essential staff, they must either present Covid-19 Test Certificate (negative PCR or Antigen) carried out a maximum 72 hours prior to the first-time paddock entry. All personnel will be included in the Participants' Registry – it is the responsibility of the Organizer to include all medical staff. Remember to establish night shifts first time entry as per the opening hours defined.



In order to access to the Medical Center a triage point will be created outside where possible. It is recommended this triage point will also give access to the Clinica Mobile. The Medical Center will provide for medical (doctor) personnel at this station.

Patients will wear a mask. Alcoholic hand sanitizer gel to clean their hands.

Patients will be screened for temperature, saturation and symptoms. If the patient shows a T  $<37,5^{\circ}$ C and with no relevant symptoms, the patient will be admitted.

## Respiratory airways symptoms will be treated always at the Medical Center.

Patients with compromised temperature and/or saturation values, together with patients with relevant symptoms for Covid-19 infection (cough, asthenia, dyspnea, myalgia, diarrhea, lack of taste and/or sense of smell, \* and following guidelines related official COVID-19 symptoms known at the time of the restart) will access the isolation room (DIFFERENT ROOM TO TRIAGE POINT), where they will be assessed by the CMO and FIM WorldSBK Medical Director.

The final responsibility in case of doubt of COVID-19 symptoms will be in charge of CMO/Medical director.

Triage admission cases:

- 1) Protocol set for all riders: all the riders who will stay overnight at the Circuit will be screened for temperature each day before the track activity in order to avoid false results due to the strenuous physical effort and environmental condition. This check will be done at the Medical Facilities every morning.
- 2) Patient arriving walking to the Medical Center: access by triage point as for previous indication.
- 3) Patient in the Paddock/Hotel with possible/severe COVID-19 symptoms: Triage by call via the Person in charge of Health & Safety Protocol named by each Team and/or Work Group who will coordinate communication with medical authorities.

# Only in the case the rider/patient is a minor or the medical condition is severe, one assistant, officially named by the rider, is allowed in admission.

The assistant admission will be through the triage access. The assistant will wait in a proper zone, i.e. waiting area of the Medical Center, respecting the physical distancing (2 meters / 6.5 ft), wearing masks.

A doctor from the Clinica Mobile will go to the Medical Center as usually to assist the rider. He will wear all the PPE as required.

Ambulances have to be cleaned and disinfected every morning and immediately after each transport.

The Triage Point as well as Isolation Room shall be provided by the Circuit. In case there are no adequate rooms available in the Medical Centre, temporary cabins shall be set up and fully operational from Tuesday 09:00 h until Sunday evening. Operation hours will start on Tuesday, Wednesday and Thursday at 09:00 h and on Friday, Saturday and Sunday at 08:00 h.



# **Medical Center Rooms**

Cleaning, disinfection of healthcare settings, PPE healthcare settings have to be in compliance with ECDC guidelines.

- > Waiting area/ other rooms (doctors meeting room, dressing room...)
- > Procedure rooms
- > Patient rooms (i.e. minor trauma room)
- > Resuscitation rooms
- > X-ray room

It is recommended, when possible, to use portable X-ray equipment to limit the movement of patients and minimize the possible transmission.

After each contact with patients all the radiology equipment (X-ray, MRI and CT scan machine gantries were present, ultrasound probes) has to be disinfected.

Plexiglass (or similar) Protective Workplace barriers shall be used in places where there is a close contact between people admitted (patients, rider assistant, etc.) and information desks/offices.

In each room will be available alcoholic hand sanitizer gel and disposable towels and hand washing facilities as much as possible.

Doctors/paramedical meeting room: it is recommended physical distance, no food and beverages sharing. Dressing room: to be respected physical distance to be respected between the different locker rooms. Access by fixed quotes.

All the rooms should be periodically well ventilated with fresh air for a minimum of 1 hour, and then periodically carefully cleaned with a neutral detergent, followed by decontamination of surfaces using a disinfectant effective against viruses.

Periodical cleaning of toilets, bathroom sinks and sanitary facilities need to be performed carefully avoiding splashes. Disinfection should follow normal cleaning using a disinfectant effective against viruses, or 0.1% sodium hypochlorite (Follow ECDC guidelines).

Waste disposable bin for gloves/masks (always follow countries/government indication) and hazardous waste must be available in all the rooms.

Waiting room seats: two meters distance between the seats.

Patient Treatment rooms:

- > Patient hospital beds distance: at least two meters between the beds.
- > Use of disposable medical beds linen and disposable rolls.

When possible, use of disposable medical devices, equipment and instruments.

Decontamination of medical equipment, devices and instruments not disposable, cleaning and disinfection of surfaces touched by patient, have to be applied at the end of each medical treatment.



For the effective Disinfection see the official guidelines about the contrast of SARS-Cov-2 infection ( i.e. ECDC technical report on disinfection, ECDC guidelines).

Resuscitation rooms: Rooms where aerosol generating procedures have been performed (i.e. intubation) need to be ventilated with fresh air for 1-3 hours, before cleaning and admitting a new patient.

In buildings where windows do not open and a ventilation system functions in a closed circuit, HEPA filtration should be used for the recycled air.

After ventilation the mentioned area should be carefully cleaned, and then, decontaminated with a disinfectant effective against the virus (see official guidelines ECDC).

# **PPEs Medical Center personnel:**

To wear in compliance with the ECDC guidelines:

- > Disposable FFP2 or FFP3 respirator non-valved version.
- Goggles or face shields. If Goggles they need to fit the user's facial features and have to be compatible with the respirator. Decontamination after each treatment.
- > Long-sleeved water-resistant gowns should be used to prevent body contamination. If water-resistant gowns are not available, a single-use plastic apron worn over the non-water-resistant gown can be used. To be used only for a treatment.
- > Disposable Gloves/double gloves to be thrown away after each treatment or more if needed.

To compliment: Disposable Shoe covers and disposable caps.

General cleaning and disinfection of all surfaces and of all the Medical Center areas at the end of the day.

The principle of cleaning and disinfection will be applied to the triage area.

Briefing and debriefing of the whole staff will be done in open air respecting the physical distancing.

#### ANTIDOPING

Antidoping procedures will be defined by the FIM always subject to the regulations set by WADA (World Anti-Doping Agency) for the FIM Superbike World Championship.

# TRACK SIDE SERVICE - MEDICAL

Distancing at the ground post:

- > Organize at each ground post a Sanitizer Station with hand sanitizer gel.
- Every member of the medical service staff must keep at least the physical distancing of 2 meters (6.5 ft) by each other when they stay at the ground post and not in action.



Protective clothing: All the medical services staff on track will wear their own PPE:

- > a mask type FFP2;
- > a personal suit;
- > safety helmet;
- > disposable double gloves;
- > goggles or face shields.

If goggles they need to fit the user's facial features and have to be compatible with a respirator.

Decontamination of the goggles or the face shield after each treatment.

After any action, use the antiseptic gel to clean the hand with the gloves on, remove the upper one and replace with a new one. Change the disposable gloves if broken.

How to act during a crash: all the personnel (medical) will go to the accident site always wearing:

- > mask type FFP2;
- > personal suit;
- > safety helmet;
- > disposable double gloves;
- > goggles or face shields.

Rescue and evacuation actions by the medical personnel will be done on the riders always with full PPE.

Always Remember: don't touch the rider if not strictly necessary.

If the rider will be transported in the ambulance assist, if it is possible, to help him to wear a mask and gloves.

After any action, use the antiseptic gel to clean the hand with the glove on, remove the upper one and replace with a new one.

#### AMBULANCES STAFF

As for the ground staff posts, also the ambulances staff, will wear their own PPE: personal suit, mask type FFP2, double disposable gloves, face shield or goggles.

When the rider is transported in the ambulance, if it is possible, put the mask and gloves on him.

At the end of each action, provide to clean and disinfect the inside part of the ambulance including the stretcher and all the instruments, followed by decontamination of surfaces using a disinfectant effective against viruses, or 0.1% sodium hypochlorite.



#### TRACK SIDE SERVICE - MARSHALS

Distancing at the ground post: Organize at each ground post a Sanitizer Station with hand sanitizer gel. Every member of the track service staff must keep at least the physical distancing of 2 meters (6.5 ft) by each other when they stay at the ground post and not in action.

Even when they are not in action, they must wear their own PPE:

- > surgical mask;
- > a personal suit;
- > safety helmet (FIM doesn't set compulsory use of helmets);
- > work gloves;
- > goggles or face shield.

Avoid touching the mouth, nose and eyes with unwashed hands.

If cough or sneeze, cover the nose and mouth with a tissue, discard it immediately and sanitize hands with alcoholic hand sanitizer gel.

Use the Sanitizer Station at the ground post to keep the hands, with the gloves on, clean.

#### **RECOVERY VEHICLES**

The personnel will wear their own PPE:

- > a personal suit;
- > a surgical mask;
- > work gloves;
- > face shield or goggles.

#### CLEANING

At the end of each day, provide cleaning services, to wash, clean and disinfect the suits and the bibs of all the personnel medical and marshalls with soap and water at least 60 degrees and dry for the day after. Clean (spray) shoes with alcoholic 70% solution.

#### **MEDICAL CARS**

Each member of the medical cars staff will wear: personal suit, FFP2 respirator, disposable double gloves, face shield or goggles and they should also wear an apron or disposable gown over their suits given the interventions they may be required to make which may otherwise contaminate their suits.

The medical cars staff must stay outside, close to the car, during the practice sessions and races keeping the distance between each other of 2 meters (6.5 ft). All the medications, drugs and medical equipment must be inside the medical car ready to go. Always in radio communication.

Go immediately inside the car just in case intervention is requested and after radio communication "to go".



Change the disposable gloves and the FFP2 after any intervention.

As well as for all the other medical personnel, at the end of each day provide to wash and clean the suits and the bibs with soap and water at least 60 degrees and have dry for the day after. Clean (spray) the shoes with alcoholic 70% solution.

Medical cars have to be cleaned and sanitized at the end of the day and after any intervention in which a rider or other person gets into the car and/or frequently if necessary.

#### SAFETY CARS

Each member of the safety cars staff (1 & 2, first lap and warm up lap) will wear: personal suit, FFP2 respirator, disposable double gloves (medical staff) / driving gloves (drivers), face shield or goggles and they should also wear an apron or disposable gown over their suits given the interventions they may be required to make which may otherwise contaminate their suits.

Each member of the safety car staff (Safety car 1 and 2) must stay outside, close to the car, during the races, until the race is valid, keeping the distance of each other of 2 meters (6.5 ft), leaving all the medications, drugs and medical equipment inside the car ready to go. Always in radio communication.

Go immediately inside the car when intervention is requested (i.e. restart procedures), after radio communication to go.

Change the disposable gloves and the FFP2 after any intervention.

As well as for all the other personnel involved in medical actions, at the end of each day provide to wash and clean the suits and the bibs (if present) with soap and water at least 60 degrees and have dry for the day after. Clean (spray) the shoes with alcoholic 70% solution.

Safety cars have to be cleaned and sanitized at the end of the day, after any possible medical intervention and/or as frequently as necessary. No other people other than the safety cars staff are allowed to get into them.






## Annex 3: Temperature Control Diagram






## Annex 4: Paddock Access Diagram for Essential Staff






## Annex 5: Paddock Access Diagram for Guests


