FIM ENVIRONMENTAL TROPHY GENERAL INFORMATION



The Fédération Internationale de Motocyclisme (FIM) is pleased to call for nominations for its annual Environmental Trophy. Through this Trophy, the FIM wishes to recognise and show its appreciation for those who have significantly contributed to the preservation and protection of the environment, and to encourage a greater awareness of environmental and social concerns.

ELIGIBILITY

The Trophy may be awarded to individuals, groups or organisations (e.g. FMNs, Clubs, Organisers, Circuit Owners, Manufacturers, teams, etc.) that have made a significant contribution to enhancing environmental awareness and environmentally and socially responsible behaviour by:

- Organising events in the field of motorcycling (sporting or tourism activities) that are sustainable from an environmental, social and/or economic point of view.
- Developing a project or programme that contributes to enhancing the sustainable practice of motorcycling in line with the Sustainable Development Goals.

The FIM Environmental Trophy may be granted for a single project or for activity carried out from September 2021 to August 2022.

Nominations may be submitted by a FMN (compulsory for clubs organisers & teams), any relevant stakeholder involved in the activity, or by a third party. FIM Staff and CID Members are not eligible to nomination for the Trophy.

In keeping with the FIM Environmental Code, the candidates are not allowed to submit the same project more than once (whether successful or not) and the successful candidate shall not apply the following year.

As per the FIM environmental sustainability policy, the applicant must demonstrate:

- That the organisation has inspired others through motorcycle sport to change their behaviour in the long run towards reducing or minimising adverse impact on the environment;
- and/or
- That the organisation has taken concrete action through motorcycle sport to create a positive impact on the environment and society;
- That an environmental improvement has been made or environmental awareness has been raised in a measurable way as a result of the applicant's actions. The candidate must demonstrate that through the project presented, it contributes significantly to achieving the objectives of sustainable development.

SCOPE OF THE TROPHY

Examples of sustainable programmes, events, campaigns that may be eligible include, but are not limited to:

- Climate action: generation or development of alternative energy, clean energy promotion, greenhouse gas emissions mitigation
- Sustainable event management: pollution prevention/recycling/green purchasing, projects or programmes addressing environmental and social issues through sport
- Environmental education
- Sound-level reduction
- Fans' engagement
- Any other innovative environmental enhancement ideas or programmes
- Contribution to the achievement of the UN Sustainable Development Goals
- Projects aimed at leaving a positive legacy in the community.

ALIGMENT WITH THE SUSTAINABLE DEVELOPMENT GOALS

This year we consider it of key importance that candidates align their projects with the UN sustainable development goals. (https://www.un.org/sustainabledevelopment/sustainable-development-goals/)

JURY

All nominations will be evaluated by an independent Jury which will be composed of one member of the FIM Awards and Recognition Committee, the CID Director and three independent experts appointed by the CID Bureau who must declare any conflict of interest at the beginning of the process.

TROPHY PRESENTATION

The winner will be invited on stage during the annual FIM Awards Prize Giving Ceremony. The FIM reserves the right not to award the prize, should no candidature be in accordance with the present requirements.

NOMINATIONS

Please submit your nomination as soon as possible, but no later than <u>31 August 2022</u>.
