**WorldSBK/WorldSSP/WorldSSP300 Team Licenses for Teams participating in the 2025 FIM Superbike World Championship (WorldSBK, WorldSSP, WorldSSP300).**

Dear 2025 WorldSBK, WorldSSP, WorldSSP300 Teams,

From 2025, the WorldSBK/WorldSSP/WorldSSP300 Teams licence is mandatory. WorldSBK, WorldSSP/WorldSSP300 Teams must request a Team license according to the category they compete in. If the team has riders in both or all categories and the team's name is the same, the 2nd license is not required. The team will only be charged for the highest team license.

Please find below the Art. 1.29.3 of the FIM Superbike, Supersport, Supersport 300 World Championships Regulations:

---

*Teams will, in principle, be comprised of two riders. The names of the teams will be composed of three elements:*

- 1. The name of the Manufacturer of the motorcycle.*
- 2. The name of the Team (mandatory except where the Team name is the same as the Manufacturer).*
- 3. The name of one principal Sponsor (Optional).*

*Teams in each class, holder of a team licence will compete for a Championship. In the absence of a license, the team will not score points. In this case, the classification of the race will not be altered and the points will be distributed according to this classification.*

*For teams with more than one rider, in each race, points scored by the best placed rider and the worst placed rider in the team, including substitutes and replacements, will count towards the Team Championship.*

*In the case of a Team entered in an event with more than two riders, but starting the race with one/two riders, only the best placed rider will score points counting towards the Team Championship.*

The Team Licences can be ordered via an online form and the requests will be managed as follows:

- 1) Once your form is filled in, an invoice will be sent to the contact person's e-mail address indicated in the form.
- 2) Your Team Licence will be issued once your payment has cleared.
- 3) A PDF of the Team Licence will be sent to the contact person's email address indicated in the form.
- 4) Your official Team name will be added to the official FIM Team list on the FIM website.
- 5) If you also want to receive the physical licence, you can request on the form selecting the option "Physical Licence sent by DHL". A delivery fee of EUR 30 will be added to your invoice.

After delivery of the licence, Team will be registered on Sportity to receive personal documents and communication from the FIM WorldSBK Stewards Panel.

From 2025, the registration of one of your team members (by default Team Manager) is mandatory.

The Sportity registration procedure will be sent in a separated document.
