4. Cancellation of rider's licence:

Please note that in case of cancellation of a licence and its insurance, an amount of EUR 10 will be charged to the FMN. The price of the licence will be credited to the FMN at the end of the current month.

An FMN asking for the licence cancellation guarantees that the licence has not been used by the rider in any event (World Championships, Continental Championships or NMFP).

Please submit all cancellation requests by e-mail to extranet@fim.ch

Please mention in your e-mail the name, first name and licence number of the rider, the reason for cancellation and in which event/championship the rider was participating.

- rule for licence cancellation in Track Racing:

When an FMN orders 2 one-event licences for the same rider and for the same weekend, one for the day of the qualification and one for the Final, if the rider is not qualified for the Final, the FMN can cancel the second unused licence. In these cases, the EUR 10 fee won't be applicable. The conditions are the following:

1. Both licences should be ordered for the same place, same weekend, same rider.
2. Mention "Not – selected after qualification" as reason for cancellation.

5. Training Camps:

The Training Camp licence art. 62 985 11 and its associated insurance product is valid in each discipline.

FIM Training Camps are open to national and foreign riders holding a FIM Training Camp Licence.
